**ORDER DENYING DEFENDANT'S MOTION TO CORRECT ILLEGAL SENTENCE**

**THIS MATTER** is before the Court upon Defendant's *Motion to Correct Illegal Sentence*, filed pursuant to Fla. R. Crim. P. 3.800 on October 21, 2021. After review of the Motion, court file, and applicable law, the Court finds as follows:

The Defendant first argues that 240 penetration points were wrongly assessed in this case. The Court addressed the victim injury points in an order dated June 10, 2005. *See Order.*

Defendant's second claim of error alleges that he was illegally sentenced to 22.5 years in Florida State Prison as to counts 3 and 4 in CF03-00002-XX. The Court, during sentencing, announced that it was bound by a 1995 guidelines scoresheet. The maximum sentence allowed was 270 months, or 22.5 years. The Court never indicated that it was its intention to sentence the Defendant to the lowest permissible sentence. The sentence is legal.

Based on the above, it is **ORDERED AND ADJUDGED** that Defendant's *Motion* is **DENIED**. Defendant has thirty (30) days to appeal this order to the Second District Court of Appeal.

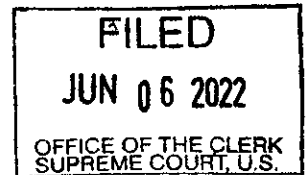

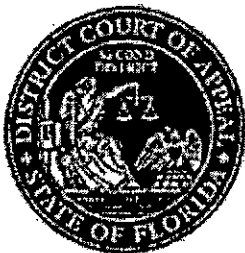


