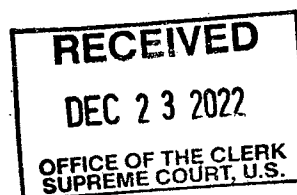

## **Petitioner's Statement**

To the Honorable Clerks and Judges of the United States Supreme Court:  
Pursuant to this Court's Rule 30, I, Petitioner, Michael A. Tulipat respectfully requests that the time to file its Petition for Writ of Certiorari in this matter be extended 10 days up to and including December 23, 2022.
