CORRECTED MOTION TO PROCEED  
*IN FORMA PAUPERIS*

Pursuant to Rule 39 of the Rules of this Court, Petitioner JERRY LEON HALIBURTON respectfully moves this Court for leave to file his accompanying Petition for Writ of Certiorari to the Supreme Court of Florida without prepayment of fees and costs and to proceed *in forma pauperis*.

Capital Collateral Regional Counsel-South (“CCRC-South”) is a state agency in Florida charged with the statutory responsibility of providing legal representation in both state and federal capital postconviction proceedings to persons convicted and sentenced to death in Florida. Part IV, Chapter 27, Florida Statutes (1994), is the CCRC-South Enabling statute. CCRC-South, or its predecessor Capital Collateral Representative (“CCR”), have been the counsel of record for petitioner in his state postconviction proceedings since January 21, 1992.


The undersigned counsel is a member of the Bar of this Court and is an attorney employed by CCRC-South.

Mr. Haliburton was declared indigent and permitted to proceed *in forma pauperis* by the Circuit Court of the Fifteenth Judicial Circuit, in and for Palm Beach County, Florida, on March 12, 1992. Mr. Haliburton has proceeded in this status in all subsequent filings challenging his conviction and sentence of death before the Fifteenth Judicial Circuit Court, as well as the Florida Supreme Court, the United States District Court for the Southern District of Florida, the United States Court of Appeals for the Eleventh Circuit, and this Court.

Mr. Haliburton filed a motion requesting this Court to allow him to proceed *in forma pauperis* on June 27, 2022. In support, he attached a document from the circuit court deeming Mr. Haliburton indigent. He now submits this corrected motion including details of the state court appointment of counsel.

WHEREFORE, Petitioner asks this Court to grant his motion and allow him to proceed *in forma pauperis* in this action.
