



I. QUESTIONS PRESENTED

The lower courts have failed to apply the Laws of the United States. The USA holds a 90 percent failure rates in the State Courts regarding the Protection of Crime Victims after they report a violent crime, and the offender is often free to continue the abuse of his victims for life. Why?

My constitutional rights have been decimated. My human rights have been ignored which violates numerous US laws, treaties as well as basic Human Rights laws.

Under 42 US Code 1983 is regarding the Civil action for deprivation of rights. In Jogi v. Vogas 480 F.3.d 822 (7th Cir 2007) the Seventh Circuit decided that an individual may sue for damages under section 1983 when he or she is not informed of his right to consular notification. The Seventh Circuit began its analysis by concluding that the phrase “and laws” in section 183 should be read to include treaties (The Yale Journal of International Law Vol, 37:1).

“Every person who, under color of any statute, ordinance, regulation, custom, or usage, of State or Territory or the District of Columbia, subjects or causes to be subjected, any citizen of the United States or other person within the jurisdiction thereof to the deprivation of any rights, privileges or immunities secured by the Constitution and laws, shall be liable to the party injured in an action at law, suite in equity, or other proper proceeding for redress.”

Why is this court allowing Human Rights to be decimated under the 14th Amendment to the Constitution regarding due process and equal protection? The 1, 5,4,8 and 9are impacted as well. Numerous state actors violated House Concurrent Resolution 172. The Landmark Row Vs Wade is impacted.

I have two people dead and five miscarriages that I know about already from the court’s failures. in my family. How many more must die before the court start following the laws of the USA?

Jodie Louise Byrne, a mother, wife of 22 years, creator of JLOUISEELIZABETH, a not for profit, respectfully request to petitions this court for a writ of certiorari to review the judgement of the United States First Circuit Federal Court.

The decision by the First Circuit and denying even a hearing is attached. A Complaint filed with that court is attached to the Appendix detailing the egregious behavior of the Federal Judges.

VI JURISDICTION

I, Jodie Louise Byrne, invoke this Court's jurisdiction under 28 USC 1257, having timely filed this petition for a writ of certiorari within ninety days of the First Circuits Judgement on January 24, 2022.

VII CONSTITUTIONAL PROVISIONS INVOLVED

Constitutional rights which are Human Rights have been decimated under the 14th Amendment to the Constitution regarding due process and equal protection. The 1, 5,4,8 and 9 are impacted. All the laws in the Table of Contents have been violated and other case noted have confirmed all. All State actors violated House Concurrent Resolution 172.

The Landmark Row Vs Wade is impacted as the petitioners was forced to terminate a pregnancy due to the Domestic Violence. Society embraced retaliation by an overwhelmingly ignorant community. The lower courts all ignored the US Constitution Under the 1[st], 4[th], 5[th][,] 9[th], [and] 14[th] Amendment

VIII. STATEMENT OF THE CASE

My daughters have been denied their human right to know and love their mother and grandmother. I cannot have more children after several miscarriage. I was denied my economic rights after a 22-year marriage which tossed me into poverty, slavery and I was utilized by the US government as a courtesan. Economic Violence has made it impossible to adopt or have even a bed.

Below are a few of the Human Rights violations that are ongoing today...It's been a nightmare since I reported abuse in 2007. Family laws are ignored, and Constitutional rights denied, and this behave is deadly for all women. This case is a typical Domestic Violence Case in the USA. I AM NOT SURE WHY I AM STILL ALIVE? I SHOULD BE DEAD BY NOW GIVEN THE GIFTS SOCIETY HAS GIFTED.

1. The Human Rights Violations

Death Certificates should recognize cause of Deaths due to Domestic Violence

My mother recently died a premature death on February 28, th because of the First Circuit Court failure to seriously review the case. Domestic Violence should be listed as a cause of Death-on- "Death Certificates" along with all other causes. Economic violence has a cause-and-effect relationship.

France Elizabeth Yarrington left this earth without ever seeing her granddaughters after they were kidnapped by the broken court in 2008 after I filed divorce from Mr. Deyesu. We know abusive men kill the mother of their victims. We know some use guns and others use the court system.

Domestic Violence is a Terminal Illness in the USA/DNR/Suicide

We know stress causes death. I have been denied health care since I filed for divorce in 2008 and I know my mother cried a lot which exasperated the decline in our health over the severe Human Rights infringements which are ongoing.

Damages present and ongoing are too numerous to include all. A hearing is needed. My mother overheard a conversation I had regarding the concurrent economic abuse before she quit and utilized a DNR order written when she was not mentally capable of distinguishing how that is to be employed.

My mother received six stents in her and accepted the most advanced medical intervention possible in early 2021. Its illogical what the lower court allowed to occur. No hearing on anything I brought forth was ever reviewed. This is just one example that proved deadly.

I could not even return to the USA for my mother's funeral due to the economic violence present. The first Circuit disrespected me and ignored a human beings request numerous times. I am just a crazy batted mom who is broke,

Suicide is not promoted and DNR orders were not intended for domestic victims. Assisted suicide is for terminally ill people who have suffered for years and years with no hope in sight for a cure. **Is Domestic Violence a terminal illness in the USA?**

The court should have followed the laws and ordered equal rights to me, and I guarantee my mother would be alive today. The decade plus of our lives would have been happier with my economic rights and constitutional rights which I asked for enforced. I wonder how many people die waiting for Justice?

Economic Rights affect all even Inheritance Laws

The human rights violations continue today and toward inheritance laws. In France, there exist solid inheritance laws that are safety nets for Domestic violence victims. My mother's brother took the entire 5 waterfront lots, the café, and the liquor licenses.

My brother took the rest of what my mother held. That left zero for me and my daughters. I can't fight it because the estate Atty want up front cost for estate work. There isn't food money for women that are abused. Like my x husband, the male's surrounding my mother will not be respectful because my mother died with a small bank account while the men live large.

This is typical behavior with Domestic Violence and it essential that the courts follow all the laws regarding equality and economic rights when women request a divorce from an abusive spouse after 22 years. A convicted wife beater who viciously attacked another female employee and never spent a night in jail. What country are reading about here? Bel Air, Maryland USA...

The second wife certainly has my money and that of my daughters. France, has many social ills corrected? The second spouse is not entitled to a lot in Europe and the children inherit most. The inheritance laws that France adopted would help the USA considerably regarding Domestic Violence which is economic Violence.

The giant business that is the Court System would not like to lose business therefore a moral inheritance law will not become precedent. The average person never recovers from the 90 percent failure rate regarding domestic violence and the family courts. How will I buy a house? Do I have to continue to have sex with men I don't want to for housing?

I Lost Everything over Mis information regarding Domestic Violence

I agree with Johnny Depp's recent court statement where he stated "at 50 years old I have lost everything" over Domestic Violence and society's ignorance regarding Domestic Violence. The difference is he has a home and some money.

I have nothing. I was tossed to the streets to be a courtesan an abused in the USA. Most women are tossed into poverty and are slaving away just to breath while the men take all.

The amazing thing is that Johnny Depp gets entertained in VA. I am in poverty and get ignored due to all the human rights violations on going. His case gets center stage. I ask for 20 million in restitution for my daughters and I and I receive not one hearing before the court. I have not seen my daughters since I filed divorce. I wonder where the Justice is in the USA?

A. Abortion Rights when the Life of the mother is Endanger, Protection Orders.

The Journey toward Motherhood

I was pregnant 8 times in life that I am aware of. All with my x husband, Mr. Deyesu. After three miscarriages in row. (I intentionally tried to get pregnant again and I want more children. The economic abuse gifted which are human rights violations made this impossible.) Mr. Deyesu did not want any more children. He had tried to kill me in May 2006 around my Mother's Birthday.

I remember sending Mr Deyesu to the Drs so the Dr could address why he tossed me down the steps and chased me and tried to strangle me. I sent him to the Drs. I did not report this to the Police at the time. He is the father of my daughters. I don't want him in jail.

Mr. Deyesu was given a prescription for clonazepam and anti-depressants. I remember it was filled on my mother's Birthday, May 18, 2006. The drugs made Mr. Deyesu feel better, and I was able to get pregnant. Things never lasted long before they got worse. He stopped taking the medication.

Endorse Economic Rights for Women

I ended my pregnancy and Marriage that Dec 6, 2006. I had two doctors' consent for a medically necessary procedure. I do not endorse abortion. I prefer to endorse economic rights for women and children.

No one can predict how that pregnancy would have ended or what violence would had occurred further. I know horrible things occurred after I reported a crime, and they still occur because the court failed me and my daughters. I hurt today. Most women have their first pensions and own their own home at

my age. Men date women that get their economic rights. I must endure abuse for life.

Not all pregnancy's end with a human being as I know with 5 miscarriages already.

I regret that society elevates money over a human life. Mothers and women are not supported in the USA. This case is evident of that fact. I regret not seeing that pregnancy till the end. I had very little support in the USA and still do not.

Mothers Life is At Risk

You have the right to terminate your pregnancy in the USA after 5 miscarriages and after your husband tries to kill you. The family courts have the right to bring their own ideals regarding abortion to their court rooms. Bias and retaliation. Isn't that discrimination? How they ignore evidence of lovely photos of my children and I In NY right before I filed for divorce.

Federal Protection Orders Ignored

Federal Protection orders issued by District Court Judge Eaves were violated and a police report was issued. The same Judge ignored the evidence. It was presented in court by me. I am the giver of the report to the Sheriff department who created a report of my x husband threats on November 13, 2007.

Mr. Deyesu violated, and police department did not arrest him. There wasn't a report with out me. The Court used misinterpreted the rules of procedure to cover up her error. Look how my x husband has acted as any good psychologist would predict.

B. The Rights of a Mother VS the Rights of Father and the Rights of a Women VS The rights of a Man. Equal Rights for Children as Human Beings.

Maternal Rights and Children's Rights have been Decimated devoid of Cause

I did not see my kids again after I filed for divorce. I received very little economic rights and I have been tossed into poverty for life against all known laws. My constitutional rights and that of my daughters have not existed.

2. Appeal

Not one Hearing was Granted in Federal Court

I appealed to the First Circuit in Boston. I was denied even one hearing in District Court in Maine. I was denied a hearing in Boston. They did not even make the other party respond. It was a farce. The other party was told they were not allowed to speak at oral argument when there was not one scheduled.

There was not any penalty for ignoring the Federal Courts orders. If I ignored a Federal Court order, I am sure I would be in jail. I do not count as a human being in the United States of American. I count numerous mistakes and this court can ignore the errors and destroy my life further or act moral and lawful.

IX. REASONS FOR GRANTING THE WRIT

10% success rate is Insufficient out of 100%...If the courts in the US were Doctors a Majority would be in jail for killing their clients

The courts only achieve 10 percent of the domestic violence custody cases in a legally acceptable manner. The other 90 percent are sentences to a lifetime of torture. These are the darkest hours of this court.

I was recently reading immigration laws. I am a product of illegal immigration to the US. It appears my Irish Grandparents failed to adhere to immigration laws when they arrived in the USA. It is truly astounding how this court has managed to change course from draconic practice as society is slow to keep up.

The wealthy white Ukraine is allowed in as the people with darker skin who walked to the border in Mexico and aren't getting Pizza delivered are denied entry.

Discrimination, that I clearly read regarding innocent Asian and wealthy people appears in the same immigration procedures today equal to DV procedures. Bias and not the rule of law is the standard. The role of the Supreme Court appears hypocritical.

Winston Churchill said... many great things. "To improve is to change: to be perfect is to change often." It was Winston Churchill's statue in London across from Westminster that brought me back across the Atlantic. "We will fight". The values of Statues... I am not sure there is a Statue today that would make me cross the pond.

Legally Kidnapping?

Mothers are having their children legally kidnapped in the USA today against all known laws. You ask how does that occur? Women are being tossed into permanent poverty because of bias. All mothers are working mothers some are paid and recognized while others are discriminated against and devalued. Attorney's work for money. The fathers hold the treasure chest. Some women like to stay home and breastfeed and forgo material things.

Hillary Clinton Unreported Undervalued Income by Women

I voted for Hillary Clinton because she rightfully stated women are the caretakers of the world. They are mostly unpaid. All mothers are working mothers. What needs to change. People need to start recognizing this fact and pay women who are working at home the value of a Judges Salary.

I could not take CARE OF my aging parents or my growing children. Family values are the precedent. When you steal money from women/mothers you really harm society.

You cannot assign different values to women who are judges and women who touch the future in a different way. Equality is important. We have laws in this country that are being ignored and being applied differently to all.

Ninety percent of non-abusive mothers report they begin court proceeding with custody of their children. By then end of the court proceedings 80

percent of the identified offenders have custody and the crime victims are placed on supervised probation.

X. Conclusion

Constitutional rights which are Human Rights have been decimated under the 14th Amendment to the Constitution regarding due process and equal protection. The 1, 5,4,8 and 9 are impacted as well. All state actors violated House Concurrent Resolution 172.

The Landmark Row Vs Wade is impacted as the Appellant was forced to terminate a pregnancy due to the Domestic Violence. Society embraced retaliation by an overwhelmingly ignorant community. Free unrestricted access has not occurred. The court allowed my daughters to call me a Murderer over 15 times and rewarded Mr. Deyesu for teaching young women to say such horrid things. It was documented by social workers.

It's safe to say my daughters were denied a Wellesley education. International perspectives are essential to create a person's view from all angles that's why we have CT and MRI s.. we have progressed and this court need to continue to.

The courts success rate is a catastrophe rate 10 percent. The courts are failing ninety percent of the time. This is well document since for 50 years plus.

Fathers who plead for sole custody are the same documented and convicted wife and child abusers. The laws are already written to consider this fact. Bias is the rule of law not the laws written by congress.

This court must understand women have a right to report abuse, file for divorce and retains custody of our children and economic rights. This is not what has happened in this case.

The courts have become like the defense industry. Impoverish mothers by acting judges is not moral. Despite how anyone feels about abortion, despite how anyone feels the worth of a stay-at-home mom is... Or the feeling they have toward a woman who was married for 22 years and was not the breadwinner of the family. We must follow the laws that are written. The economic rights alone are devastating.
