# Sworn Affidavit of Financial Status

I have provided the "In Forma Pauperis" as requested. I felt the form was a little ambiguous as the debts and expenses were more consistent for a person who is NOT incarcerated.

I felt the need to explain my financial status a little more clear with exhibits.

- Each month, the Ok.-D.O.C. puts \$11.56 on my account to buy Hygiene. No way does this cover the cost.
- Each month, my mother puts \$100<sup>00</sup> on my books/account. There are several months where she simply can not afford to help me.
- On 6/16/22 the I.R.S. provided me with \$1,862.50 from the stimulus.

For the First time in Four years I was able to buy New Clothing:

- 1) 2 pair of shorts \$13<sup>00</sup> each
- 2) 1 pair of Shoes \$85<sup>00</sup>
- 3) 1 pair of Boots \$150<sup>00</sup>
- 4) 1 pillow \$9<sup>00</sup>
- 5) 2 wash cloths \$2<sup>00</sup> each

I also had to buy "stationery" to continue fighting for my freedom and to prove my Actual/Factual Innocence. \$250<sup>00</sup>

Just in the past in the Past Four (4) months the Oklahoma Department of Corrections has charged me \$531.27. Multiply that by the full 12 months.

That is a total of \$1,054.27 as I keep a copy of all my receipts.

The OK-D.O.C. ensures that the law library and stationery are expensively price to "dissuade" inmates from accessing the Honorable Courts.
