ORDER

Before **TYMKOVICH**, Chief Judge.

Talya Cyd Zuckerman has filed a motion to withdraw from further representation of Appellant Diann Ramcharan in this appeal. The motion to withdraw is GRANTED.

The district court has made the requisite finding of eligibility for appointment of counsel pursuant to 18 U.S.C. § 3006A, and James L. Hankins¹ is appointed as counsel for Ms. Ramcharan. Pursuant to § 3006A, Ms. Zuckerman is appointed nunc pro tunc to the date the notice of appeal was filed in this matter, and that appointment ends with the entry of this order appointing new counsel.

Within ten days from the date of this order, Ms. Zuckerman shall transmit to Mr. Hankins copies of all documents in her possession that are pertinent to this appeal and not otherwise available via PACER and/or CM/ECF. Also, within ten days, Mr. Hankins shall file an entry of appearance in this appeal.

Ms. Zuckerman has filed a designation of record and transcript order form. Within 20 days from the date of this order, Mr. Hankins shall file any supplemental designation of record, and any supplemental transcript order form. If a transcript is ordered by Mr. Hankins, he must file a CJA 24 form in the U.S. District Court for the District of Colorado. Questions regarding the filing of a CJA 24 form should be directed to the district court Clerk's Office.

Appellant's opening brief shall be due 40 days from the date the record on appeal is filed in this court. See Fed. R. App. P. 31(a)(1); 10th Cir. R. 11.2(A). The Clerk of the U.S. District Court for the District of Colorado shall wait at least 20 days before transmitting the record on appeal to this court.

The Clerk's Office shall transmit a copy of this order to the Clerk of the U.S. District Court for the District of Colorado. Ms. Zuckerman shall transmit a copy of this order to Ms. Ramcharan forthwith.
