**MOTION FOR EXTENSION OF TIME TO FILE  
PETITION FOR A WRIT OF CERTIORARI**

Petitioner respectfully requests a thirty-day extension of time to file a petition for a writ of certiorari from the U.S. Court of Appeals for the First Circuit's decision in *United States v. Serrano-Delgado*, No. 19-1652, 29 F.4th 16 (1st Cir. Mar. 22, 2022).

The undersigned has been working diligently to review the case and to determine whether a certiorari petition is viable and would suit Mr. Serrano's interests. This review process required discussing several matters with Mr. Serrano

and his trial team. The undersigned did not represent Mr. Serrano at trial and the attorney with primary responsibility over this appeal, involving a seven-day jury trial, has since left the office. Although the undersigned has made significant headway, the review process is still underway. Given the breadth of the record, the nature of the issues on appeal, and counsel's other responsibilities, we respectfully submit good cause exists for extending this deadline by thirty days. If we determine a certiorari petition is warranted, the petition can be completed within a month.
