

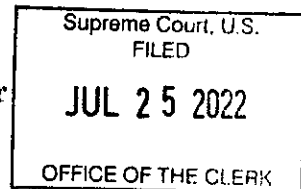

The petitioner asks leave to file the attached petition for a writ of certiorari with prepayment of costs and to proceed in forma pauperis.

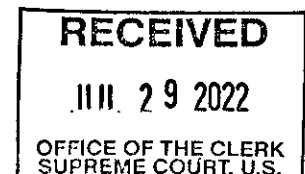
Petitioner has not previously been granted leave to proceed in forma pauperis in any other court.
