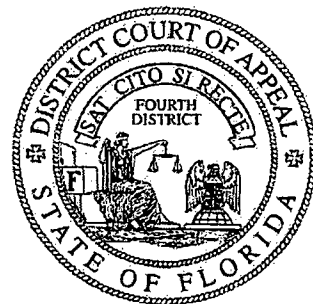


ORDER DENYING DEFENDANT'S MOTION FOR REHEARING
