ON MAY 16, 2022, before the last day for filing.

on July 5, 2022, I did not satisfy this certain specified
obligation.

REASONS FOR GRANTING THE PETITION

A petition for a writ of cert. will be granted only for compelling reasons, indicating this Honorable court's character which calls for your exercise of supervisory power because under rule 10, parq. (c) of this supreme court rule book, the 6th Cir. of Appeals court the Potter Stewart court house has decided an important federal question in a way that conflicts with your relevant decisions of this court rule 29, parq. (2) which say?

rule 29. 2. A document is timely filed if it is received by the clerk in paper form within the time specified for filing; or if it is sent to the clerk through the United States postal service by first-class mail, if submitted by an inmate confined in an institution, a document is timely filed if it is deposited in the institution's internal mail system on or before the last day for filing and is accompanied by a notarized statement on declaration in compliance with 28 U.S.C. § 1746 setting out the date of deposit and stating that first-class postage has been prepaid.

I, follow all the character of this court's rule above 29, parq. (2) when I mail the 1pg. motion for pauper status, and 1pg. financial affidavit, by (MDOC) prepaid first-class postage by PRISONER EXPEDITED LEGAL mail, in a SEAL ENVELOPE, which cost me 53¢ & another 53¢ obligation to send the same process to opposing COUNSEL.
