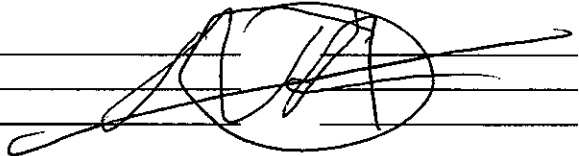
**AFFIDAVIT OR DECLARATION

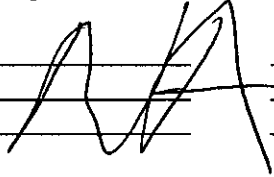
