ORDER

This matter is before the panel of Kitchens, P.J., Maxwell and Ishee, JJ., on the Motion for Leave to Proceed in the Trial Court filed by Roderick Taylor. The panel finds Taylor's claims of ineffective assistance of counsel fail to meet the standard set out in *Strickland v. Washington* and are without merit. The panel finds that the remaining claims have either been addressed in prior proceedings or could have been raised at trial and in the direct appeal. Those claims are procedurally barred. Miss. Code Ann. § 99-39-21. Notwithstanding the procedural bar, the panel finds that those claims are also without merit.

IT IS THEREFORE ORDERED that the Motion for Leave to Proceed in the Trial Court filed by Roderick Taylor is denied.


