## **MOTION FOR LEAVE TO PROCEED *IN FORMA PAUPERIS***

In accordance with Rule 39 of this Court, Petitioners Tremain Lamar Braxton, Timothy Roy Mason, and Darrell Lee-Lamont Summers II seek leave to file the attached petition for a writ of certiorari without prepayment of costs and to proceed *in forma pauperis*. Petitioners are unable to afford the cost of representation in this matter.
