

On petition for rehearing concerning application for a "*Writ of Habeas Corpus*" is in accordance with Rule 44 of the United States Supreme Court. by the media in New York, are integral and directly responsible for what happened to the Honorable Ester Salas, *inter alia*.


5. The pretext for Her Honor being removed as the sitting judge.... Supra.
