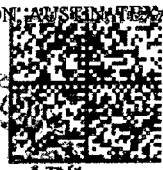
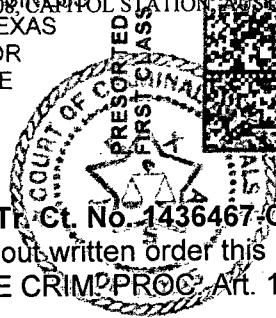

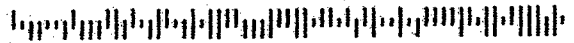

The trial court has considered the application for writ of habeas corpus, the State's original answer, and official trial court records in the above-captioned cause and the applicant's previous habeas proceedings. The trial court finds there are no controverted, previously unresolved facts material to the legality of the applicant's confinement which require an evidentiary hearing, and recommends the Court of Criminal Appeals dismiss the instant writ application because the applicant fails to include sufficient specific facts establishing that his current claims could not have been presented previously because the factual or legal basis for the claims were unavailable; or that, by a preponderance of the evidence, no rational juror could have found the applicant guilty beyond a reasonable doubt. Tex. Code Crim. Proc. Ann. art. 11.07, § 4(a).


1. the indictment, judgment and sentence, and docket sheets in cause number 1436467;

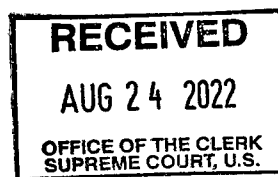

The applicant filed the instant *pro se* writ application, cause number 1436467-C, on April 1, 2022. The Harris County District Clerk's Office electronically notified the State about this application on May 13, 2022. The State's answer is due June 13, 2022. The trial court's deadline to designate any issues that need to be resolved is July 5, 2022. Tex. Code Crim. Proc. art. 11.07, §§ 3(b) and (c).

## II.

The State denies the factual allegations made in the instant application, except those supported by official court records, and offers the following additional reply:

### **REPLY TO APPLICANT'S GROUNDS FOR RELIEF**

The applicant asserts five grounds for relief. *Writ Application at 6-15*. However, if a subsequent writ application is filed after final disposition of an initial application challenging the same conviction, the Court may not consider the merits of or grant relief based on a subsequent application unless the application contains sufficient specific facts establishing that:

- (1) the current claims and issues have not been and could not have been presented previously in an original application or in a previously considered application filed under this article because the factual or legal basis for the claim was unavailable on the date the applicant filed the previous application; or
- (2) by a preponderance of the evidence, but for a violation of the United States Constitution no rational juror could have found the applicant guilty beyond a reasonable doubt.

Tex. Crim. Proc. Code Ann. art. 11.07, § 4 (a).



The instant writ application was filed after the final disposition and denial of the applicant's previous writ application, cause number 1436467-B, wherein he challenged the merits of the same conviction. In this application, the applicant fails to include sufficient specific facts establishing that the current claims could not have been presented previously because the factual or legal basis for the claims were unavailable; or that, by a preponderance of the evidence, no rational juror could have found the applicant guilty beyond a reasonable doubt. *See id.* Therefore, the Court may not consider the merits of, or grant habeas relief and the applicant's instant writ application should be **DISMISSED**.

### III.

The applicant raises questions of law and fact which can be resolved by the Court of Criminal Appeals upon review of official court records and without need for an evidentiary hearing.
