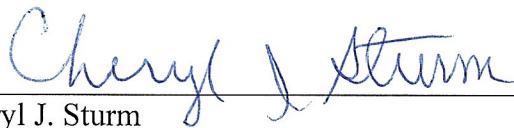
MOTION FOR LEAVE TO PROCEED IFP
