MOTION FOR EXTENSION OF TIME TO FILE CERTIORARI

COMES NOW, the Petitioner, Carrie Helen Fine, pro se, and moves this Court for an extension of time in which to file her Petition For Certiorari. In support of this motion, the Petitioner states:

1. The Petitioner, Carrie Helen Fine, was convicted and sentenced in Hardee County Circuit Court in the state of Florida in Case Number 2018-CF-000051.
2. Petitioner filed a Direct Appeal to review her conviction and sentence to the Second District Court of Appeals of Florida in Case Number 2D20-0856.
3. The Appellate Court issued a per curiam affirmance on October 27, 2021.
4. Ms. Fine timely filed a Motion For Rehearing which was denied and Mandate issued on December 30, 2021.
5. This Honorable Court has jurisdiction to review a Petition For Writ of Certiorari within 90 days of the denial of her Motion For Rehearing her direct review/appeal.
6. The Petitioner is required to file her Certiorari no later than ^{March}~~May~~ 30, 2022 and wishes to do so.
7. The Petitioner is currently incarcerated at Lowell Correctional Institution in

8. Ocala, Florida. She is in a wheelchair and housed in a medically disabled dormitory.
9. Ms. Fine cannot travel to the law library at her institution and is therefore dependent on the law clerk visits and providing her with research materials in order to complete her legal work.
10. Additionally, the entire Institution was on lockdown/quarantine status due to the resurgence of the Covid virus on the compound in late December 2021 and into January 2022. During that time,. There were no law clerks in the law library and I was unable to get any assistance or materials to complete the Petition for Certiorari I wish to file.
11. The Petitioner has no knowledge of the law and needs time to research issues and law in this matter. Therefore, Petitioner is requesting that this Honorable Court grant her an additional 60 days in which to file her Petition for Writ of Certiorari.
12. The State of Florida is represented by the Office of Attorney General of Florida in the Tampa, Florida division.

WHEREFORE, the Petitioner, Carrie Helen Fine prays this honorable Court will allow her and extension of 60 days in which to file her Petition For Writ of Certiorari in the instant case.

I originally sent an extension request on February 15, 2022 that the law clerks instructed about. It was not correct and I recieved a letter from you stating so dated 3/1/2022. The law clerks are not trained or paralegals. They made a new extension request that I am sending. I sincerely hope that it is correct this time.

They have left out a few details of why the extension is needed. I suffered a stroke on 11/30/2016 because I was serzed and held for 6 hours, during which I was a severe diabetic and not allowed to take my insulin. My right hand (I am right handed) is completely numb and has no grip. The wrist is in much pain and the arm has limited range of motion.

Medical is in process of diagnostics but has stated it may be residual to the stroke. The point being, that I cannot write with my left hand and the law clerks will only type out things. They won't write for me. I am also learning disabled and my comprehension is not very good.

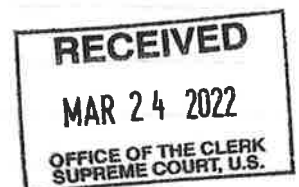
