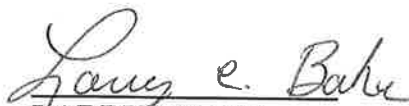

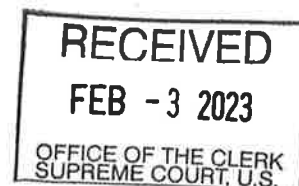

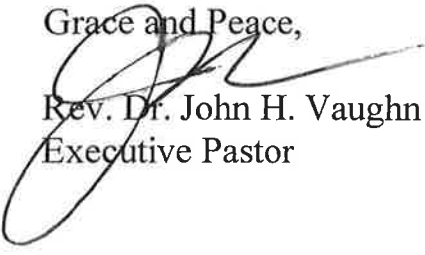

without my daughter's egypt and

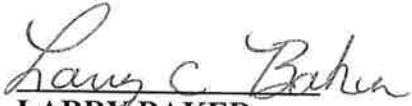
