

Pursuant to this Court's rules 13.5, 21, 22, 30 and 33.2, Pro Se Petitioner, Dean Allen Steeves, respectfully requests a 45-day extension up to and including July 17, 2022, to file his Petition for a Writ of Certiorari re *Dean Allen Steeves v. United States Internal Revenue Service*, United States Court of Appeals for the Ninth Circuit case

No. 20-56065. Petitioner has attached the Ninth Circuit's judgment in the case issued on November 18, 2021 as Exhibit "A". Petitioner has also attached the Ninth Circuit's denial of Petitioner's Petition for a Panel Rehearing, dated , March 4, 2022 as Exhibit "B". Petitioner is invoking this Court's jurisdiction under 28 U.S.C. §1254(1) and the time to file a writ of certiorari, without an extension, will expire on June 2, 2022. Petitioner's application is timely because Petitioner has filed his application for extension of time more than ten (10) days prior to the expiration date for filing.

REASONS FOR REQUESTING AN EXTENSION OF TIME

- 1)** Petitioner's work requires that Petitioner travel back and forth between California and Oregon every month for at least 10 days at a time.
- 2)** In addition, the Public Law Libraries in Petitioner's immediate area of California, Rancho Santa Fe, are permanently closed until further notice and the closest Public Law Library is in San Diego an hour away and is open only for a maximum time of only 2 hour sessions per person, per day.
- 3)** Based upon the reasons above, which have severely interfered with Petitioner's ability to provide a succinct and clearly expressed Petition for a Writ of Certiorari by June 2, 2022, Petitioner is respectfully requesting this Court to grant a 45-day

extension up to and including July 17, 2022, to file his Petition for a Writ of Certiorari.
