
Comes Now Erika Jacobs, Appellant, in the above styled case to request my writ of certiorari be reconsidered for its landmark importance. The Plaintiff has requested that the record from Oklahoma be submitted to the Supreme Court of the United States for review.

The Plaintiff request a motion of reconsideration for the following reasons:

1. The Plaintiff has a right to appeal the Tax court case pursuant Title III: Appeals from the United States Tax Court 1.
2. Pursuant rule 40 if the appellant court; it requires a response be given for approval or denial (Please explain to the court clerk what an opinion is because they seem to get that confused with a response to the motion[the response from the judges tells the appellant the reason for approval or denial of the writ of certiorari])
3. The Plaintiff submitted a preponderance of evidence in support of her writ of certiorari.
4. The Plaintiff needs the judges to review her writ of certiorari and not a staff attorney or clerk for proper resolution of this matter.
5. The lower court did not handle the tax law suit as it has other law suits of the same caliber. The tax commission of Oklahoma had been given 11 months to resolve the matter but did not. Thus, a complaint was filed in federal court for resolution.
6. The Appellant has experienced much discrimination as it pertains to her civil rights in the state of Oklahoma.

History:
