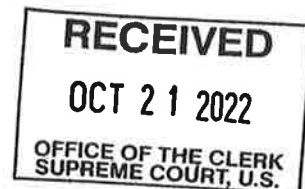
Salutations,

I've prepared this **official legal document** specifically to (1) **give notice**; (2) to address an actual **conflict of interest**; and (3) to address potential **impropriety¹** and/or **collusion of nonjudicial court employees**.

In Mr. Westmoreland's pro se pursuit of seeking post-conviction relief, the erratic conflict with the filing and review processes has infringed on both equal protection and due process guarantees of the United States Constitution. Furthermore, the collusive-infused (mis)handling of Mr. Westmoreland's case(s) reflect the disregard of the respective Courts and/or their Offices of the Clerk, in properly and adequately protecting law and federal constitution in accords to governing rules therein. Mr. Westmoreland raises this actual conflict, and politicality seems to inadvertently be a driving force in conflict, since claims raised are both novel and complex.

On **Saturday 9/3/2022**, Westmoreland prepared and mailed a Writ of Certiorari with postage paid for -- in concert with priority delivery for **Tuesday 9/6/22** to the United States Supreme Court. Equivocally, even though the United States Supreme Court received


filing on September 7, 2022, it was docketed on September 29, 2022. (No. 22-5718)

Meanwhile, on Wednesday 9/7/2022, the Georgia Supreme Court denied Mr. Westmoreland's Certificate of Probable Cause {S22H0255}. However, Westmoreland received the decision at Dooly State Prison on Wednesday 7/14/2022. According to Rules of the Georgia Supreme Court, (i.e., **Ga. S.Ct. R. 1, 11, 13, 27, 60, 61**), Westmoreland had 10 days from the decision to file a Motion for Reconsideration and/or Motion to Stay the Remittitur. Under the circumstances, of expediency and being a pro se incarcerated litigant -- considering the disadvantage of a less than 5 days to prepare, on Friday 9/16/2022, Westmoreland prepared both a *Motion for Reconsideration* and *Motion to Stay the Remittitur* with postage paid for -- in concert with priority delivery before Monday 9/19/2022 to the Georgia Supreme Court. Interesting enough, documents show that the mail was actually received on September 17, 2022. According to the court's own Rules, since 9/17/2022 fell on a Saturday, the next business day would be Monday 9/19/2022. Equivocally, according to the court's public website, both motions were filed on Tuesday 9/20/2022, with the Motion for Reconsideration being filed "***past time***". As a direct result of the bad-faith acts and/or the bureaucratic delay in the filing, the Georgia Supreme Court consequently ***dismissed*** the Motion for Reconsideration of Certificate of Probable Cause and ***denied*** Motion To Stay The Remittitur on October 4, 2022. Decision was received at Dooly State Prison on October 07, 2022.

First, it's pertinent to note that technically Georgia Supreme Court lost jurisdiction to hear the case on *July 15, 2022* under **Georgia Constitution (Sec. VI, Art. IX, Par. II.)**. Secondly, it's equally as important to understand that Ga. Supreme Court **Rule 60(2)** states that "[A] remittitur shall be transmitted to the Court from which the case was received as follows: *"In other cases as soon as practicable after the expiration of 10 days after the entry of the judgment or upon the denial of a motion for reconsideration, see Rule 27, unless otherwise ordered."*

There is a actual and very crucial conflict of interest and potential collusion with the (Georgia and United States Supreme) Court's and Clerk's alike, in that the consistent procedural irregularities in Westmoreland's pro se filings are both mischievously and intentionally botched. The pervasive recklessness in the highest Courts of Law respectfully, is devastating and implicate Mr. Westmoreland's federal constitutional guarantees. Furthermore, if an American Citizen can't rely on the Due Process of the Court system to remedy legal matters appropriately to seek equal and fundamental justice, there's inadvertently no longer a "legal" remedy available.

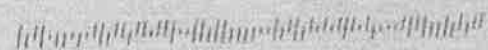
