I am self employed through Instacart. I moved from New York back to my native state of Pennsylvania to start fresh. I have been back in Pennsylvania since November 3rd 2021 and have built short term and long term goals for myself. Since my cases was still in the Appellate Division First Department, I also had another filing in the NYC Family Court and this Petition for Writ of Certiorari, I have found it easier to stay with my relatives and work my instacart job until I have this petition filed which is seemingly the last resort in court endeavors to overturn the case dispositions.

I short term and long term planned that no matter the circumstances I would diligently look for better job opportunities and my own private housing and continue to grow and better my situation after the filing of this petition for Writ of Certiorari. The courts was very overwhelmingly impacting my time and money to be able to advance myself through other ways that I had orchestrated for myself such as my law undergrad program that I took time off of my objective to complete and advance myself in college because of the time and costs of the state courts and disrupting my life.

I figured if I get my son back through this court of last resort I will be in a position by then to improvise and work to get him out and then go back to continuing to build my life and future.

The state of New York and the State of Pennsylvania has not supplied me with any of their financial relief programs such as I was denied for approximately 3 Covid rent relief assistance of \$650 despite being in a qualifying financial bracket. I haven't been allowed SNAP or TANF in the State of NY but in Pennsylvania I was allowed SNAP. I was approved of Pandemic Unemployment Assistance but then was never sent any funds.

My functioning has been purely off of resources I have been able to obtain through employment, college funds, and friends from out of state. But I have been strategizing to get out of debt and higher income range.

I have been separated from my spouse since June 15th 2020 with a pending divorce on the grounds of irretrievably impaired relationship related reasons. He is also the subject-child's biological father that I have had relationship with since November 2012 and marriage did not make the relationship work or last.
