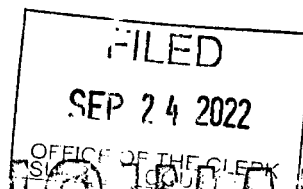

QUESTION(S) PRESENTED

1. Can Sheriffs or courts make up charges to arrest a disabled man to unlawfully detain me to keep detained while the sheriffs search parents home then do a illegal interrogation with no audio and pencil-whip Snyder, say snyder sold dope. Then charge Snyder with violent crimes with no evidence
2. Can courts illegally convict snyder after refusing bail for 1 year and keeping snyder in administrative segregation. Hurting snyder so bad he and his family fear ever traveling through Snohomish with no evidence.
3. Can courts impose fines for illegal conviction after physically and mentally destroying snyder, and remind snyder each month of the horrific crimes done to him.
4. Can courts, Washington, Snohomish keep fake accusations on history of a person that is mentally disabled allowing Public to bully Snyder
5. Can States (Washington) allow state and federal agencies to unlawfully label people as gang members. Especially snyder that honestly loves our constitution and hates violence and follows the commandments.
6. Can Snohomish county courts, sheriffs violated Federal laws and our constitution to scare snyder so bad he is afraid to appeal because they keep adding on his criminal history. STATEMENT OF THE CASE

December 28 was arrested for violating no contact order in June. A fake charge, Snyder been targeted/profiled by police. Some drug addict lied they did DNA test ect. Nothing and still charged Snyder rape charge then girl changed her story and they plastered Snyder all over news, papers and locked me in segregation after cops interrogated me with no Audio or video. they wrote I said I sold the girl dope. I've never sold any dope they lied. Keeping me a Disabled handicapped man in Administrative Segregation violated American Disabilities Act I was and did not know this till now. They made my living condition so bad I Pled guilty to Distribution and there was never any drugs in anybodies Possession. I cried every night, guards would call me bad names and 1 guard broke my hand. Get All records WA. Supreme Court said they filed them. So U.S. Supreme Court. Plus over the years tons accusations on my record and when cops pull me over there computer says Im highest ranking Mexican Mafia member in Washington. Thats crazy and not true. Im very disabled now and this discrimination today by Cops, Anyone that runs background check, Courts, Old Friends, Jails, Rentals, Jobs. Please read my verbatim in Court April 6th 2022 Kootenai County District Court. I spoke of this in depth asking for help.

Statement of the case

Snyder was also accepted into DOSA 2005 before sentencing. But, the judge denied Snyder. Saying Distribution of meth is a very Serious Crime. Problem is James Snyder never Distributed any drugs. That kid wouldn't get out of the car when my girlfriend tried taking her home. Her boyfriend was a drug dealer. I told cops I smoked her dope. Not I sold her dope. Title II American Disability Act. Being denied based on a disability. Because I was too disabled to know it takes drugs in Cops or courts possession to uphold a drug conviction. I and everyone involved had zero drugs in possession. I'm still paying L.F.O. for drugs with no drugs to uphold a fine or conviction. Plus All accusations and convictions mixed with Washington saying I'm Highest Ranking Mexican Mafia member in Washington State. Thus, a bounty on my head was active

REASONS FOR GRANTING THE PETITION

Because counties, states and USA don't realize the significant harm they do to Americans down the road on internet, background checks etc leaving Accusations on a persons criminal history, especially to a disabled man where others already make fun of me is a terrible Miscarriage of Justice and Bearing false witness against thy neighbor, violating Gods laws. Triggering my PTSD from a county I won't ever go back to.

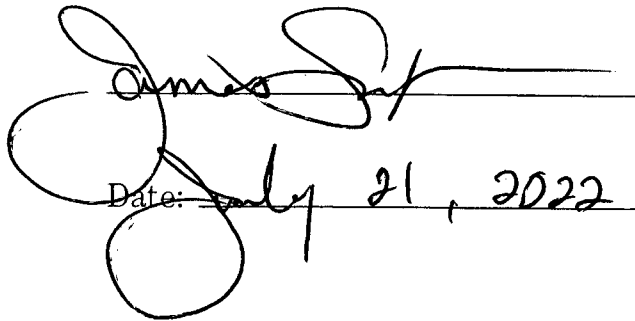
Snyder still paying drug fines for that cause number w/no drugs for evidence.
