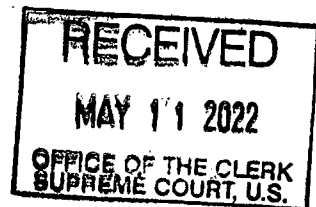

APPLICATION FOR AN EXTENSION OF TIME

Pursuant to Rule 13.5 of the Rules of this Court, Applicant Erin Carter hereby requests a 60-day extension of time within which to file a petition for a writ of certiorari up to and including Monday, July 18, 2022.

JUDGMENT FOR WHICH REVIEW IS SOUGHT

The judgment for which review is sought is *Erin Carter v. St. Tammany Parish School Board; Amy T. Burns*, No. 21-30237 (February 17, 2022) (attached as Exhibit 1). The United States Court of Appeals for the Fifth Circuit after oral argument affirmed the lower courts judgement, *Erin Carter versus St. Tammany Parish School Board, et al.*, No. 19-9651 (March 29, 2021) (attached as Exhibit 2; including order and reasons).

JURISDICTION

This court will have jurisdiction over any timely filed petition for certiorari in this case pursuant to 28 U.S.C. § 1254(1). Under Rules 13.1, 13.3, and 30.1 of the Rules of this Court, a petition for a writ of certiorari was due to be filed on or before Wednesday, May 18, 2022. In accordance with Rule 13.5, this application is being filed more than 10 days in advance of the filing date for the petition for a writ of certiorari.

REASONS JUSTIFYING AN EXTENSION OF TIME

Applicant respectfully requests a 60-day extension of time within which to file a petition for a writ of certiorari seeking review of the decision of The United States Court of Appeals for the Fifth Circuit in this case, up to and including July 18, 2022.

1. Applicant has sought and requested legal counsel to assist in the preparation of this petition. An extension of time will permit the necessary time necessary to complete a cogent and well researched petition.

2. The extension of time is also necessary because of the press of other legal matters Applicant has been and is currently a party, *Louis Carter, III v. Erin Jackson Carter* (No. 2020-0002912). A 60-day extension for the Applicant would allow Erin Carter the necessary amount of time to effectively contribute to all matters and would allow sufficient time for proper preparation.

CONCLUSION

For the foregoing reasons, Applicant respectfully requests that this Court grant an extension of 60 days, up to and including July 18, 2022, within which to file a petition for a writ of certiorari in this case.
