Dear Mr. Harris:

I write on behalf of all parties to request an extension of the briefing deadlines in this case. The Court granted the petition for a writ of certiorari on April 17, 2023. I understand that the case is likely to be argued during the Court's October 2023 sitting. Petitioners' opening merits brief is currently due June 1, 2023. On behalf of all parties, we respectfully request, under this Court's Rule 30.4, that Petitioners' time to file their opening brief and any joint appendix be extended to and including June 22, 2023, and that Respondents' time to file their brief be extended to and including August 14, 2023. Under this Court's rules, Petitioners' reply brief would be due 30 days later, which is more than 10 days before the earliest possible argument during the October 2023 sitting.

Counsel seek the proposed extension given the press of preexisting work. Petitioners' counsel must attend to the following deadlines between now and early June:

- May 1, 2023: Opening brief due in *Borja, et al. v. Nago, et al.*, No. 22-16742 (9th Cir.);
- May 9, 2023: Oral argument in *Norfolk Southern Railway Co. v. Surface Transportation Board, et al.*, No. 22-1209 (D.C. Cir.);

- May 19, 2023: Merits brief due in *Pulsifer v. United States*, No. 22-340 (U.S.);
- May 24, 2023: Oral argument in *Saba Capital CEF Opportunities 1, Ltd., et al. v. Nuveen Floating Rate Income Fund, et al.*, No. 22-407 (2d Cir.);
- May 26, 2023: Reply brief due in *TBL Licensing LLC v. O'Donnell*, No. 22-1783 (1st Cir.); and
- June 6, 2023: Cert-stage reply brief due in *Verdun, et al. v. City of San Diego, et al.*, No. 22-943 (U.S.).

Counsel for all parties request these extensions of time.
