Liu's request for a certificate of appealability is denied because he has not "made a substantial showing of the denial of a constitutional right." 28 U.S.C. § 2253(c)(2). Jurists of reason would agree, without debate, that all of Liu's claims were meritless or procedurally defaulted, for substantially the same reasons provided by the District Court. See Miller-El v. Cockrell, 537 U.S. 322, 327 (2003); Slack v. McDaniel, 529 U.S. 473, 484 (2000). Jurists of reason would also agree, without debate, that the District Court did not abuse its discretion in denying his requests for case-related materials. See Bracy v. Gramley, 520 U.S. 899, 909 (1997).
