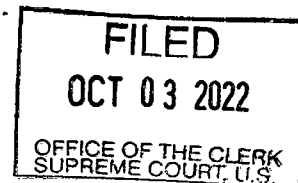

fashion.

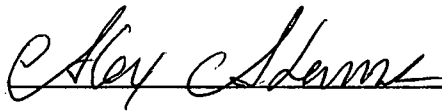
They can deduct money from Inmate Trust fund as I set deposits.
