## JUDGMENT ENTRY AND DECISION

ON AFFIDAVIT OF DISQUALIFICATION in *State of Ohio v. Vandell Slade*, Hamilton  
County Court of Common Pleas, General Division, Case No. B1903162.

Defendant Vandell Slade has filed an affidavit pursuant to R.C. 2701.03 and Article IV, Section 5(C) of the Ohio Constitution seeking to disqualify Judge Robert A. Goering from the above-referenced case.

Mr. Slade alleges that Judge Goering is biased against him and favors the prosecution. In support, Mr. Slade claims that in May 2021, he advised the judge of a problem with his attorney but the judge said that Mr. Slade was “stalling” by filing repeated motions to remove counsel. The judge’s ruling, Mr. Slade argues, is preventing him from raising affirmative defenses.


For the reasons explained below, no basis has been established to order disqualification of Judge Goering.

As an initial matter, “[a]n affidavit of disqualification must be filed as soon as possible after the incident giving rise to the claim of bias and prejudice occurred,” and failure to do so may result in waiver of the objection, especially when “the facts underlying the objection have been known to the party for some time.” *In re Disqualification of O’Grady*, 77 Ohio St.3d 1240, 1241, 674 N.E.2d 353 (1996). The affiant has the burden to demonstrate that the affidavit is timely filed. *In re Disqualification of Capper*, 134 Ohio St.3d 1271, 2012-Ohio-6287, 984 N.E.2d 1082, ¶ 11. Mr. Slade has failed to explain why he waited until August 2022 to seek Judge Goering’s

Mr. Slade. Further, an affidavit of disqualification "is not a vehicle to contest matters of substantive or procedural law." *In re Disqualification of Solovan*, 100 Ohio St.3d 1214, 2003-Ohio-5484, 798 N.E.2d 3, ¶ 4. Therefore, it is outside the scope of this matter to determine whether Judge Goering has prevented Mr. Slade from raising affirmative defenses. Mr. Slade may have other remedies for such legal arguments, but that issue cannot be litigated in an affidavit of disqualification.

The affidavit of disqualification is denied. The case may proceed before Judge Goering.


