#### MOTION FOR LEAVE TO PROCEED IN FORMA PAUPERIS

The petitioner, Tony Terrell Clark, through counsel, asks leave to file the Petition for Writ of Certiorari to the Supreme Court of Mississippi tendered herewith without prepayment of costs and to proceed *in forma pauperis*. As per the attached order, Petitioner was declared indigent, was appointed representation by the Public Defender, proceeded *in forma pauperis* at trial and on direct appeal. 
