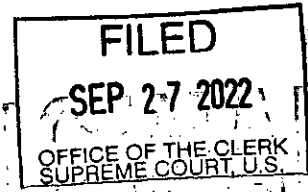



STATEMENT OF FACTS

On Thursday March 17, 2022, Harry and Cynthia Sur Green III we're leaving Southern Trail RV Park at 2690 Arena Road, Unadilla, Ga traveling in our 740Li BMW. As we were traveling down Arena Road turning left, we noticed a black and white Dooly County Sheriff's pickup truck, the same truck that's been watching us inside the park. I noticed the truck starting rolling before we even passed it. We made a right hand turn onto Pine Street then left to Piggly Wiggly's parking lot. As Harry Sur Green was getting out of the car to walk inside the store, Lt. John Shedd turned on his lights and said get back in the car. Lt. Shedd said "I need your driver's license and Registration and ID". Sur Green Stated He didn't need a driver's License to drive his vehicle. Then Lt. Shedd said "I am going to write you two tickets and you're under arrest and your car will be towed, then he told Sur Green to get out the car". Sur Gre said he was in the safety of his own car and we were not getting out. Harry Sur Green and I both were calling 911 several times for help. saying they didn't have any person that could assist us. So, we rolled our windows all the way up and they tried to open our doors but we kept them locked. My Husband Harry Sur Green III pulled away from the sheriff's and their buddies knowing they were trying to Rob, Rape, and Kill us. The Anger and the Rage showed to us was crazy - we had done NOTHING! Sur Green pulled forward to go out the other exit by the store. Lt. Shedd yelled in his radio, "their on the run...their on the run" about 10-15 cars came out of nowhere - out the fields, from behind the buildings, across the street and from the store Piggly Wiggly's itself. A man in an older white Dodge Ram truck was Ramming us as well. Cynthia Was yelling and screening their hitting us and destroying our vehicle. It was like some TV show. Lt. John Shedd was really mad, face turned red as he was trying to open Sur Green's car door and another at my (passenger) door.

Harry Sur Green III Showed Lt. John Shedd his Asylum and World Passport he said 'They are Fake and put them in his back pocket. I called 911 again and asked for a State Trooper, the dispatcher said "we could not request a State Trooper". FIVE (5) Sheriff's met me at the end of the building saying again she's on the run, These sheriff's all big guys weighing at least 250-300 lbs or more threw me to the ground, one of them put his knee in my back while the other held and handcuffed me from behind then shoved me into the car. I thought this was my last day on Earth, I was scared and feared for my life. WE HAVE PEACE NO MORE!
PHYSICALLY, MENTALLY, AND EMOTIONALLY DISTRESSED and drained from the careless "act" and did so with Evil Intent and Bad Purpose. Lt. John Shedd has deprived us of our life, liberty, and property and violated us in front of other people. We were searched, kidnapped, and property seized. "The Humiliation"

When I arrived at Dooly County Jail I was put into a holding cell for about 10 minutes, Sgt Bowen(35) took my documents that the sheriff gave her and went through everything inside. I told her those are documents of proof but she did not listen to me. Sgt. Bowen took my pictures and fingerprints and then told me to take a shower, Lt Bowen told the guard to put me in the Solitaire room! (Very nasty attitude towards me). The room was nasty the toilet was corroded trash in the drain and whatever else was in it. I had no sheet or mattress cover, a very thin blanket and I was very very cold on the plastic thin mat. I told them I was claustrophobic and asthmatic. I had diarrhea for 3 days. Scared to death not knowing anything and not understanding what was really going on and what I just went through and my family, husband and my parents who are in their eighties now and I do help take care of them.

About 30-40 minutes later they brought in my husband Harry Sur Green III and I was happy to see him. Joyful to know they did not separate us and I could see and hear him. Randy Lamberth Willing and Wilfully knowing did conspire to to set me up with a gun charge, saying he was not a part of the Sheriff Dept., He was just trying to find out what happened.

She (my aunt) put my grandmother and uncle in the nursing home and then threw me the remaining bills. Well, to make a long story short, I got to my grandparents house. My Aunt called the State along with an angry friend and told them I was frauding the State so that started everything. Jealousy and people with evil intent. The State wanted me to pay for their care in the nursing home. I refused... it was already paid for by the state and their social security. I had already paid off my grandmother's remaining balance of a loan she received through a grandmother program and I also paid off the remaining balance of the Nursing Home bill for my grandmother and uncle when they died. I had no help from no one, not one family member helped or asked me if I needed any help.

I told my Attorney, Steve Griffin at that time I didn't need ^{to pay} anyone's bills but my own. They also repossessed my 2010 Jeep and 2009 Impala and 2009 Buick lucerne that I brought my parents. I loved my grandmother and uncle dearly, they were really all I had and knew that I was loved by them. They only wanted me to care for them. This hurts so much to talk about, and for the State of Illinois and this poor system (Corporation) stealing from hard working people trying to make a living for self and family. I started working when I was 14 years old to take care of my own needs.

The State said I was stealing from the Elderly and labeled me a felon. I left Illinois, I had nothing left and everyone turned against me. I started school to get my CDL license to become a Professional Truck Driver so I could take care of my family. I did not need or ever asked anyone for anything, I always made my own way. I don't smoke, drink or do any drugs (always focused) Well, here I sit in Dooly County Jail Thursday May 5, 2022 (8 weeks), now June 8, 2022. On June 17, 2022 it will be 3 Months and for what, we did nothing to no one. Harry and Cynthia Sur Green iii has been stripped of all life, Liberty and Pursuit of our Happiness.




