I, Marie Assa'ad-Faltas, MD, MPH, am the movant in this Court's original jurisdiction or petitioner in the above-entitled case. In support of my motion to proceed *in forma pauperis*, I state that because of my poverty I am unable to pay the costs of this case or to give security therefor; and I believe I am entitled to redress.

Since my false arrest on 2 December 2009, I have had to spend most of time in my defense against false charges. I do not have any time to work, generate income, or even health care. I was struck with atrial fibrillation in my incarceration from the underlying conviction.
