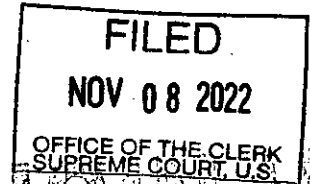

Petitioner has previously been granted leave to proceed *in forma pauperis* in the following courts:

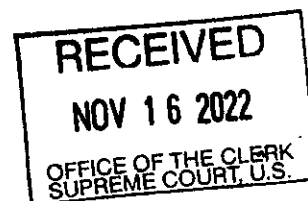

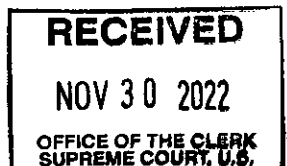

**AFFIDAVIT OR DECLARATION
