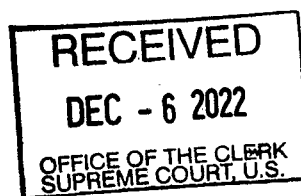
The petitioner asks for leave to file the attached petition for a writ of habeas corpus without prepayment of costs and to proceed in forma pauperis.
