



**ORDER DENYING "PETITION FOR WRIT OF HABEAS CORPUS"**

THIS CASE came before the Court in chambers on the Defendant's pro se "Levin Letter" transferred from the Supreme Court of Florida on November 17, 2021, with directions for the trial court to treat the letter as a Petition for Writ of Habeas Corpus; and the State's response filed on February 7, 2022. The Court finds and orders as follows.

The Defendant was found guilty by jury on armed burglary of a dwelling. The Defendant was sentenced to life in prison as a prison releasee reoffender. The judgment and sentence were affirmed on direct appeal. *Williams v. State*, 229 So. 3d 354 (Fla. 4th DCA 2016).

The Defendant claims that his prison releasee reoffender sentence is illegal because a 9th Judicial Circuit Court judge has found the PRR statute unconstitutional. The Court incorporates by reference the State's response, and adopts the State's reasoning and citation to contrary binding precedent holding that the PRR statute is constitutional. (See State's response attached.) Thus, absent a showing that the Defendant does not qualify as a prison releasee reoffender under the statute, the PRR sentence is not illegal and the Defendant is not entitled to relief. Therefore,

The Defendant's motion is denied. The Defendant has thirty days to appeal.
