## REQUEST FOR RELIF FROM FILING FEE

The Petitioner, Mr. David John Thistle, in connection with the Petition for a Writ of Certiorari filed to the Supreme Court of the United States, on November 5, 2022, and pursuant to S. Ct. Rule 40, respectfully requests this Court to waive the \$300 filing fee and other fees and costs associated with this petition.

1. The Petitioner served two Active-Duty enlistments in the United States Navy for a combined service of over 5 years. Mr. David John Thistle served the United States Navy in many occupations and as a member of several different Naval Commands. These Commands included but are not limited to

The Naval Special Warfare Center BUD/S, SEAL TEAM 1, SEAL TEAM 2, Explosive Ordnance Disposal Mobile Unit III, SIMA San Diego, Naval Hospital San Diego, NAVSTA Branch Medical Clinic Norfolk, The USS Cape Cod, and the USS Blue Ridge.

2. The Petitioner, Mr. David John Thistle, is a United States Navy 100% Service-Connected Disabled Veteran. Mr. David John Thistle initially served in the United States Navy for 4 years and 4 months 27 days before being transferred from active duty and Medically Retired and placed on the Temporary Disabled Retirement List with a 60% Service-Connected Navy Disability Rating.
3. The Petitioner, Mr. David John Thistle, diligently continued an arduous Physical Therapy regiment while attending Harvard University and University of Massachusetts. When medically fit, Mr. Thistle returned to Active Duty a second time. This enlistment length was 1 year 28 days before Mr. Thistle was once again transferred to the Temporary Retirement List unable to walk properly. Mr. Thistle was retired with a 60% Disability Rating from the United States Navy.
4. The Petitioner, Mr. David John Thistle, due to the seriousness and degenerative nature of his Combined Disabilities, has an effective date of rating by the United States Department of Veterans Affairs' 100% S & K. Service-Connected Disabled Veteran 09 September 1999. NOTE: The United States Department of Veterans Affairs stipulate 2 individual 100% Service-

Connected Disabilities designate the “S” Rating. The “K” rating stipulates the Service Member, Mr. David John Thistle, has a Service-Connected Legal Loss of the left lower extremity. Mr. David John Thistle also suffers from undiagnosed-misdiagnosed Traumatic Brain Injury Tumors and requests the Court will understand the format of this case complaint Writ of Certiorari is due to an understandable adaptation for his disability.

5. Currently, due to the nature of the economy and the amount of dedication and the delays of these Federal Court Complaints originally filed on 13 December 2021 Mr. Thistle is experiencing a homelessness situation and is legally considered as a “Transient Disabled Veteran.”

The Petitioner, Mr. David John Thistle, a 100% Combat Related Disabled Veteran, does, for the aforementioned reasons requests the totality of all Court Fees be hereby waived by the Supreme Court for all cases concerning the illegal altering of Article 1 Par 2 Sec 2 of the Constitution of the United States and the Negligence of Duty by Elected and or Appointed Federal and States’ Officers.

*Comes now Mr. David John Thistle, Petitioner in the above styled case and affirming under 28 U.S.C. (Sec) 1746 does state as follows:*


- 1. I am a Veteran of the United States Navy. I served in the Active Duty Navy from June 24, 1988, to November 20, 1992, before being placed on the Temporary Disabled Retirement List with a 60% Service-Connected Disability Rating. I returned to Active-Duty Naval Service November 29, 1995, until December 26, 1996, when I was once again placed on the Temporary Disabled Retirement List with a 60% Service-Connected Disability Rating. Both of these Active-Duty Naval periods were served under Honorable Character of Service Conditions.*

2. *On January 31, 1997, under 26 U.S.C. (Sec) 104(b) The Office of the Judge Advocate General of the United States Navy deemed my Service-Connected Disabilities are in fact tax exempt.*
3. *I am currently rated by the United States Department of Veterans Affairs as 100% S & K, Service-Connected Disabled.*
4. *I have filed claims against the Respondent alleging that my Constitutional Rights as a Naturally Born Citizen of the United States who has obtained the age of 25, and who was willing to meet Residency in any State when elected or upon Election especially, OHIO, ALASKA, and NEW HAMPSHIRE, to timely become a Ballot Candidate under Article 1 Sec. 2 Par. 2. were limited to negatively affect my timely filing of Ballot Forms, truncate the Ballot Candidacy timeframe, and negatively impact my abilities to properly Raise Campaign Funds.*
5. *I have filed claims against the Respondent alleging that the Respondent knowingly took no appropriate corrective action or actions in the unauthorized altering of Article 1 Sec 2 Par 2 on the Official State Websites of 6 States Elections Offices to mis-inform the General Public with regard to limit Qualified Ballot Candidates by restricting the ability of a current non-registered Voter and an out of State Inhabitant to become a Ballot Candidate. The unauthorized illegal altering of the Constitution to control or affect the outcome of Elections illegally is considered Domestic Terrorism by the*

*Department of Justice. The Respondent to zero Public Corrective actions to maintain FAIR ELECTIONS as his Duty of Office Requires.*

*6. In these claims, the Petitioner asserts the Rights granted under the 14<sup>th</sup> Amendment. The Petitioner asserts the 14<sup>th</sup> Amendment Rights and my Rights under 18 U.S.C.
