MOTION FOR LEAVE TO PROCEED *IN FORMA PAUPERIS*

Petitioner, Jason Daniel Sewell, pursuant to Supt. Ct. R. 39.1, asks leave to file the accompanying Petition for Writ of Certiorari to the United States Court of Appeals without prepayment of costs and to proceed *in forma pauperis*. Petitioner has been in continuous custody since September 2013. At the time of his arrest in September 2013, Petitioner was found to be indigent and appointed an attorney. 


