AFFIDAVIT OR DECLARATION

I, Robert Carter, am the petitioner in the above-entitled case. In support of my motion to proceed *in forma pauperis*, I state that because of my poverty I am unable to pay the costs of this case or to give security therefor; and I believe I am entitled to redress.

1. Income – I have no income except monthly gang pay of approximately \$14.00 a month.
2. Employment History for the past two years – I have been incarcerated since 01/2016.
3. Spouse's Employment History – I am unmarried
4. How much cash do I have – approximately \$230.00 in D.O.C. mandatory saving account and \$250.00 in my canteen account given by my family.
5. Assets – I have no assets (home or car or other real property).
6. No person owes my money
7. No person relies on me for support.
8. Monthly expenses – Family currently pays approximately \$60.00 a month for my life insurance policy.
9. No expectation of changes in income or expenses.
10. I have not and will not be paying an attorney for services in connection with this case.
11. I have not and will not be paying anyone other than an attorney any money for services in connection to this case.
12. I have been incarcerated since 01/2016, any funds I had prior to that went to bail and attorney services prior to my incarceration. My family is unable, or unwilling, to assist in providing funds for filing legal documents or hiring an attorney.
