CONSTITUTIONAL AND STATUTORY PROVISIONS INVOLVED

STATEMENT OF THE CASE

I) Petitioner filed a Rule 60 (b) motion as outlined in the federal Rules of Civil Procedure to "Reopen" his post-conviction relief motion pursuant to 28 USC 2255; so that Petitioner can challenge the validity of his conviction pursuant to 18 USC 924 (c) based upon the US Supreme Court decision in Rosemond v. U.S., 572 U.S. 65, clarifying the proof required for the intent element of aiding and abetting liability under 18 USC 924 (c); and this Rule 60 (b) motion "in error" was construed as a second/ successive 28 USC 2255 motion.

II) Petitioner filed a motion to dismiss seven (7) 18 USC 924 (c) firearms offenses based upon the US Supreme Court decision in Rosemond v. US, 572 US 65, clarifying the proof required for the intent element of aiding and abetting liability under 18 USC 924 (c); and this motion to dismiss "in error" was construed as a second/ successive 28 USC 2255 motion.

REASONS FOR GRANTING THE PETITION

The Sixth Circuit Court of Appeals has an "intra-circuit" split that needs to be decided. Petitioner's Rule 60 (b) motion in the instant case was refused, denied and rejected and transferred as a 28 USC 2255 second successive motion; However in United States District Court Case No. 1:94-cr-68-4 in an identical case, the defendant filed a Rule 60 (b) motion whereby his Rule 60 (b) motion was granted and he successfully had "several" 18 USC 924 (c) convictions dismissed by the US District Court for the Northern District of Ohio at Cleveland.

CONCLUSION

The petition for a writ of certiorari should be granted.
