THE COURT:

On February 23, 2022, declared vexatious plaintiff Yvonne Jiang filed a notice of appeal from an order entered on January 25, 2022 after the entry of a judgment. On February 25, 2022, Jiang filed a notice of appeal from an order entered on January 26, 2022 described as an order denying Jiang's motion to object to the reassignment of the case to Judge Thomas C. Falls and denying Jiang's motion to strike defendants' memorandum of costs.

As a declared vexatious litigant, Jiang was required to obtain leave of the administrative presiding justice of this court before filing her notices of appeal (Code Civ. Proc., § 391.7, subd. (a)), which she failed to do. On April 12, 2022, the clerk of this court sent notice to Jiang requesting her to demonstrate in writing within 10 days of the date of the notice that her appeals have merit and were not taken for purposes of harassment or delay.

(Code Civ. Proc., § 391.7, subds. (b)-(c).) To date, Jiang has not responded to the notice, and the time for responding has expired.

The entirety of the record in this case consists of the notices of appeal and the January 26, 2022 minute order attached to the February 25, 2022 appeal. On that scant record, the court is unable to determine that the appeals have merit and therefore declines to issue a prefilng order allowing the appeals to proceed. (Code Civ. Proc., § 391.7, subds. (b)-(c).) Consequently, the appeals initiated by the notices filed on February 23, 2022 (“U1”) and February 25, 2022 (“U”) are dismissed. (Code Civ. Proc., § 391.7, subd. (c).)
