STATEMENT OF THE CASE

The Plaintiff Samuel Dickerson filed a 42 USC 1983 complaint alledging that Springfield IL Police Officers Andrew Zander #534 and Lisa Balog #804 arrested him without Probable cause because of his race and failed to investigate the Domestic Battery / Aggravated Battery allegations of a white woman.

In the process of the unlawfull arrest Samuel Dickerson 14th Amendment right to Equal Protection rights was violated by various acts of the arresting officers set out in the 42 USC 1983 Civil Complaint

Samuel Dickerson alledged in the 42 USC 1983 complaint that his Public Defender Michael Sullivan never consulted with him in regards to Sangamon County Case No: 21-CF-829 and 22-CF-416 in a conspiracy to conceal the illegal arrest and acts of the arresting Springfield Police officers and told Dr. Phillip Pan to find the Plaintiff Samuel Dickerson in U.S. District Court of the Central District of Illinois, No: 3:22-cv-3184^{CSB} unfit to stand trial on Sangamon County Case No: 21-CF-829 and 22-CF-416 to have him unwarranted placed in the Mental Hospital because he was not ready to deal with the criminal case yet.

The Judge in U.S. District Court for the Central District of Illinois in case No: 3:22-cv-3184-
CSB never considered the Equal Protection claim against Springfield Police officers Andrew ZANDER #534, Lisa Balog #804 and the conspiracy claim against Public Defender Michael Sullivan and a interlocutory appeal, challenging the Court's Merit Review Order was filed in The U.S. Court of Appeals for the Seventh Circuit, SAMUEL DICKERSON vs Ken Scarlette, ET AL, CASE NO: 22-3167, that was "Dismissed" for lack of jurisdiction.

The Plaintiff argued that the Judge was bias and aiding in corruption in U.S. District for the Central District of Illinois, Dickerson vs. Doe, 3:22-cv-3184-CSB and Stated a cause of Action against all defendant in the case

This is a issue of "Public Importance". REVIEW OF ALL CASES By this court because the lives of innocent U.S. White citizens are at stake because of the Acts of Andrew Zander, Lisa Balog and Michael Sullivan racist acts while Acting under the color of Illinois State Laws

REASONS FOR GRANTING THE PETITION

The issue at hand is of extreme "public importance" based on the violation of A.D.A. 42 USC 812132 and the plaintiff being diagnosed with Schizo-affective Disorder and legally disabled under the Social Security Administration and being held in jail on a non-capital offense or treason against the U.S. Government, being denied medication in accordance with his diagnosis.

Being subjected to cruel and unusual PUNISHMENT after being discharged from McFarlands Mental Hospital and has been cleared for mental Health Treatment in the community but is being held in Sangamon County Jail on a excessive bail to kill or murder SAMUEL DICKERSON or break him down mentally for filing a Civil Rights case under 42 USC 1983, which is a right secured

I want a full review of the Probable cause, bail, Right to counsel and Due process and Equal Protect in Criminal, Civil and Appeal in this case or money that I request, permission into Canada or death by a firing squad or lethal injection.
The petition for a writ of certiorari should be granted.
