ORDER

Before: OWENS, LEE, and BUMATAY, Circuit Judges.

The district court has certified that this appeal is not taken in good faith and has revoked appellant's in forma pauperis status. *See* 28 U.S.C. § 1915(a). On January 14, 2022, this court ordered appellant to explain in writing why this appeal should not be dismissed as frivolous. *See* 28 U.S.C. § 1915(e)(2) (court shall dismiss case at any time, if court determines it is frivolous or malicious).

Upon a review of the record and the responses to the court's January 14, 2022 order, we conclude this appeal is frivolous. We therefore deny appellant's motion to proceed in forma pauperis (Docket Entry No. 6) and dismiss this appeal as frivolous, pursuant to 28 U.S.C. § 1915(e)(2).

Appellees' motion (Docket Entry No. 20) to maintain appellant's unredacted statement that this appeal should go forward under seal is granted. The Clerk will

publicly file the motion to seal and the redacted version of appellant's statement that this appeal should go forward (Docket Entry No. 20). The Clerk will maintain under seal appellant's unredacted statement that this appeal should go forward (Docket Entry No. 18).

Appellant's unopposed motion (Docket Entry No. 21) to file medical records under seal is granted. The Clerk will file publicly the reply (Docket Entry No. 22-1) and will maintain under seal the exhibits filed in support of appellant's reply to appellees' response to the court's January 14, 2022 order (Docket Entry No. 22-2).

All other pending motions are denied as moot.

No further filings will be entertained in this closed case.
