

Dear Mr. Harris:

Under Supreme Court Rules 30.2 and 30.4, this letter is written on behalf of Respondent Atlanta Independent School System a/k/a Atlanta Public Schools to request a forty-five day extension of time to file a response in opposition to the Petition for a Writ of Certiorari in the above-referenced matter. The Petition was filed on January 17, 2023, and docketed on March 23, 2023. The response in opposition to the Petition is currently due on April 24, 2024.

Petitioner advances complex arguments concerning the correct interpretation of the Family and Medical Leave Act and other federal law. Respondent has determined that more time beyond the thirty-day deadline provided in Rule 15.3 is necessary to review the authorities cited in the petition, evaluate Petitioner's arguments, and prepare an appropriate response. For those reasons, Petitioner asks the Court to extend the response deadline to June 8, 2023.


