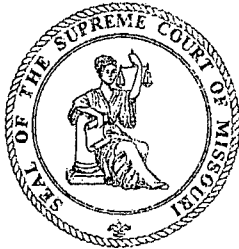


## ORDER
