STATEMENT OF THE CASE

1. Petitioner Stancu's petition for a writ of certiorari in the above-entitled case was denied by this court on May 1, 2023.

2. The questions presented by Stancu in his petition were:

A. Did the lower courts and the Supreme Court of Texas usurped the Seventh Amendment to the United States Constitution by wrongly denying Stancu's right to a jury trial?

B. Did the lower courts and the Supreme Court of Texas wrongly deny Stancu's due process rights by (a). denying Stancu's right to discovery, (b). holding a hearing without Stancu's presence, and (c). wrongly dismissing Stancu's Breach of Contract case involving a payment plan agreement for college tuition?

GROUND FOR REHEARING THE PETITION

3. Petitioner Stancu files this Petition for Rehearing because this court, namely the Supreme Court of the United States, unfairly and arbitrarily denied Stancu's petition in a blatant abuse of power, and in complete disregard of the existing laws. The following is a summary of this travesty of justice:

(a). Petitioner was informed of this denial in nine words: "The petition for a writ of certiorari is denied." There was no explanation for the reasoning of the denial, nor the name of the justice(s) who denied. The letter was signed by a clerk named Scott S. Harris.

(b). The main question of Stancu's petition was the nullification by the lower courts of Stancu's Seventh Amendment right, to have his day in court in front of a jury of his peers. The Seventh Amendment is ratified as part of the Bill of Rights of the U.S. Constitution.

(c). In front of the Supreme Court building, sculpted in stone are the words "EQUAL JUSTICE UNDER LAW." This is obviously just a facade, for the very simple fact that

there is no equal justice when millions of American citizens cannot even have their day in court. As of today, only 25% of Americans have confidence in the U.S. Supreme Court, and this rating will go lower when Stancu will present this matter to the Court of Public Opinion.

(d). There is also a disturbing bias by the U.S. Supreme Court, against *pro se* petitioners. In the entire history of this court, there is not one single *pro se, forma pauperis* petitioner who has been granted a Seventh Amendment petition for writ of certiorari. In plain English, **no money, no justice.** Case in point, is this Court's hearing of the case "Trump Too Small Hands."

4. In view of all of the above, Stancu is asking this court to grant his petition in accordance with its oath of office, and simply do its job for which is getting paid with tax payers' money.
