PER CURIAM:

James C. Winding, Mississippi prisoner # K8115, moves for voluntary dismissal of this appeal without prejudice. IT IS ORDERED that the motion is GRANTED. *See* FED. R. APP. P. 42(b).

We remind Winding that he remains barred from filing, in this court or in any court subject to this court's jurisdiction, any pleading based, in whole or in part, on his kidnapping and sexual battery convictions and sentences, unless he first obtains leave of the court in which he seeks to make the filing. *See In re Winding*, No. 21-90046 (5th Cir. Dec. 30, 2021)

Additionally, Winding is again WARNED that he should review any pending complaints, motions, and appeals and withdraw any that are frivolous or repetitive; his failure to withdraw frivolous or repetitive filings could result in the imposition of monetary sanctions; and he will be subject to additional and progressively more severe sanctions if he files, in this court or any court subject to this court's jurisdiction, any further pleading or challenge to his kidnapping and sexual battery convictions and sentences that is frivolous or repetitive.

Motion for Permission to Proceed after Sanction

ORDER:


James C. Winding, Mississippi prisoner #K8115, has filed a motion for leave to proceed after this court entered an order barring him from filing any pleading based on his kidnapping and sexual battery convictions and sentences unless he first obtains leave of the court. He seeks to challenge his kidnapping and sexual battery convictions on the grounds that there was a jurisdictional defect in his indictment, that his prosecution and arrest were malicious, and that he was not given *Miranda*¹ warnings. Inasmuch as he seeks leave to file a motion for authorization to file a successive habeas application challenging his kidnapping and sexual battery convictions, Winding would have to satisfy the requirements set forth in 28 U.S.C. § 2244(b). His motion for leave fails to raise a nonfrivolous issue with respect to those requirements. *See* § 2244(b). Accordingly, the motion is DENIED. *See Gelabert v. Lynaugh*, 894 F.2d 746, 748 (5th Cir. 1990).

Winding has ignored this court's previous warnings and has remained undeterred by the sanctions previously imposed by this court by continuing to file frivolous, repetitive, or otherwise abusive motions in his district court habeas proceeding challenging his kidnapping and sexual battery convictions and sentences. Accordingly, Winding is ORDERED to pay a sanction of \$500 to the clerk of this court, and he is specifically BARRED from filing, in this court or in any court subject to this court's jurisdiction, any pleading based, in whole or in part, on his kidnapping and sexual battery convictions and sentences until the sanction is satisfied. In the event that Winding satisfies the \$500 sanction, he shall remain BARRED from filing, in this court or in any court subject to this court's jurisdiction, any pleading based, in whole or in part, on his kidnapping and sexual battery convictions and sentences, unless he first obtains leave of the court in which he seeks to file such challenge.

Winding is further WARNED that he should review any pending complaints, motions, and appeals and withdraw any that are frivolous or repetitive, and that failure to withdraw any frivolous or repetitive proceedings could result in the imposition of monetary sanctions. Finally, although we have denied the instant motion for leave to proceed, Winding is again WARNED that filing any frivolous or repetitive pleading or challenge to his kidnapping and sexual battery convictions and sentences, in this court or any court subject to this court's jurisdiction, will subject him to additional and progressively more severe sanctions.
