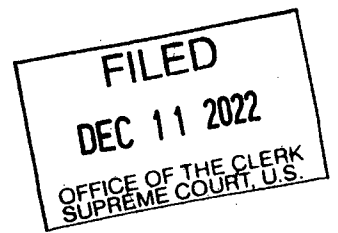

1. Petitioner has previously been granted leave to proceed in forma pauperis in the following courts regarding this case:


- (a) The United States District Court for the Western District of Wisconsin; and

PETITIONER'S AFFIDAVIT OR DECLARATION  
IN SUPPORT OF MOTION FOR LEAVE TO PROCEED IN FORMA PAUPERIS

---


I, Dante R. Voss, am the petitioner in the above-entitled case. In support of my motion to proceed in forma pauperis, I state that as a result of poverty I am unable to pay the costs of this case or to give security therefor and I believe that I am entitled to redress.

1. I do not have a spouse. During the past 12 months, I received an average of approximately \$350 for my employment with the Wisconsin Department of Corrections as an inmate worker. I expect to receive approximately \$56 next month from that same job. I do not have any other sources of income.
2. My employment history for the last two years has been an inmate worker for the Wisconsin Department of Corrections, Oshkosh Corr. Inst., P.O. Box 3530, Oshkosh, WI 54903. My current gross monthly pay is approximately \$56.
3. I do not have any cash. I have a savings account with less than \$50 in it.
4. I do not own any real estate, motor vehicles, or other assets.
5. I do not have any person, business, or organization that owes me any money.
6. My average monthly expenses are exactly equal to the pay I receive from the Wisconsin Department of Corrections. They deduct my pay at 100% for federal and state filing fees.
7. I do not expect any major changes to my monthly income, expenses, assets, or liabilities during the next 12 months.

8. I have not paid - nor will I be paying - an attorney any money for services in connection with this case, including the completion of this affidavit/declaration.
9. I have not paid - nor will I be paying - anyone other than an attorney (such as a paralegal or a typist) any money for services in connection with this case, including the completion of this affidavit/declaration.
10. I am a prisoner confined in a Wisconsin prison and 100% of any money deposited into my trust account is immediately disbursed for state and federal filing fees.

Pursuant to 28 U.S.C. § 1746, I declare under the penalty of perjury that the foregoing is true and correct to the best of my knowledge.
