I applied for a GS-12 Techincal Expert position and it was given to a young man between the age of 37 or 38.

Whenever I applied for a position I always made the Best Qualified List.

I was discriminated because I was over the age 40 per section 1614.407 of the Civil Rights Act of 1964 42 U.S.C 2000 E-5 and Age Discrimination Act in Employment (ADEA) of 1967 as amended 29 U.S.C 621
