

## STATEMENT OF THE CASE

In 2000-2001 as your Constituent and an aid to State Senator Thurman Adams and State Representative Benjamin Ewing, I was shot at and shot by the identity thief Linda Jones, on duty and off duty Delaware State Police Officers, Georgetown Police Officers, Greenwood Police Officers, Bridgeville Police Officers, Court employees, neighbors around my house and school, and other Wight gang members. The Wight gang is more than 2,000 years old and many of the murderers can be identified by their faces, or their police uniforms, from history books, paintings, and plays. I died in more than one of these shootings and very expensive stem cells were needed to resurrect me from the dead. During one attack, there was such a large mob that my family could not reach me to transfer the stem cells to my body. The Milford Bayhealth hospital used Black mixed with Blue race stem cells from the Dill Farm in Maryland that they had in stock. For the next year, I was noticeably a Black mix in race. The Blue-Black race is famously involved with the Wight gang. It acquired the Dill property in France by murdering its owners in over 1000 years of raids and attacks and winning frivolous lawsuits. The Blue-Black mix is most famous for its largest population in Niger, where they acquired the business known as the police

when the business was defunct and in bankruptcy. Senator Adams, Representative Ewing, and I were attacked at every public appearance. Linda never ceased to live at this residence with me, by the will of the Law. The police have never missed a day of employment. Linda's identity has spent every waking minute with me in my entire life. Our original residence was on Gingerwood road in Greenwood, Delaware. It was a condemned structure. It had shoddy and dangerous electricity, rotting floors and walls, poisonous water, and no plumbing. There was often nothing to eat. As an identity in the Wight gang that includes the blue one-piece uniformed police, as a raceway employee, and as a police officer when living in another identity, Linda acquired and murdered over 250 children in 1986. Between 1986-1988, I died 500 times. This was confirmed by an investigation by the State of Delaware, Senator Adams, Representative Ewing, The Towns of Greenwood and Harrington, The Delaware State Fair, and Delaware Legislature. Stem cells used to raise the dead cost more than a million dollars. To come back to life a second time, and then a third, and so on, is exceptionally expensive. I accrued a medical expense exceeding \$999,999,999,999,999.99 as a twelve year old boy due to my innumerable number of deaths and injuries that I have received from rape, beating, and disease risk inflicted on me by Linda, the

police, and others. Since my 12th year, there is not a known amount to say that is owed, since my medical expenses have exceeded hundreds of trillions of dollars. Linda was not welcomed on that farm, our original residence, by anyone. In addition to us children, Linda and her cop-faced comrades killed many Cains, some who had the Mark of Cain on their person. They also offered themselves in prostitution, and shot and killed whoever responded to be their customer. The State of Delaware and the Judicial Branch and its police powers responded to what Linda was doing in that trailer, by giving Linda a job at the Division of Child Support in Dover, Delaware. Linda used her new authority to attack the parents of any friends that I had made at Country Kids Daycare in Greenwood, Cub Scouts, Greenwood United Methodist Church, The New Jersey Surf Riders-Delaware Chapter, and Seaford, Woodbridge, Milford, Lake Forest, and Cape School Districts. I was living next door to this location when The State Fair, Crystal's Restaurant, and others donated the money for this house to be built. Greenwood Trust Bank financed the house. Nanticoke Homes began building it. As it was being built, Linda and the police murdered the Nanticoke builders. They murdered and raided the company. They murdered and raided the owner and his family across the street. This house has never been finished. The walls have never been painted. For

years, the police sold this house and only this house, as they controlled the manufacturing company and did not know how to adjust the machines. When they were sued for shoddy houses, they made their murder victim John Mervine a wanted man. They chased his identity into Maryland, and shot at him and his family on sight. They killed the owners and occupied the houses on both sides for miles along this highway, and still remain in them in identity. They stopped the open prostitution at Taylor and Messick's store in Harrington, claiming they were not allowed to be a competitive rival. They regularly steal the Taylor and Messick vans. A decade later, they formed a real estate company and possessed the Mervine's home. There have been daily to weekly violent standoffs at the Mervine residence since 1991, as they still continue to murder to try to steal the home. The factories Nanticoke Homes, New Process Fiber, and Thompson in Greenwood have not replaced their stolen manufacturing machines and supplies. These factories are empty. Only the accounting offices and reception desks have remained open for the last 20 years. The police daily robbed the Greenwood Trust Bank until it permanently closed. Shootings continued at the Greenwood Methodist church until after the new millennium. Linda's identity was hired to teach Kindergarten at Woodbridge School District. Linda and the Wight gang raided, shot and bombed the Lake Forest

Chipman Middle School and nearby streets that included Donald Chalmer's barber shop, until the town of Harrington remodeled and changed its roads and business locations. Linda taught Kindergarten or 1st Grade at Woodbridge for 13 years, killing every student in her class by Thanksgiving and working to kill every student who shared her student's identity for the rest of the year. Linda started teaching when I was in 1st Grade. On my first day of school, both in Kindergarten and in 1st Grade, I was fatally raped. Stem cells were needed and I was in the hospital for over a week, both times. I spent half of the days of my life in the Intensive Care Unit or the Emergency Room of Milford Memorial, Kent General, Christiana, St. Francis, Nanticoke, Bayhealth, and other hospitals in my first six years. When we moved into this house, the police, family members, the firemen, and others visited this house to rape me daily. I was bleeding blue and red under my skin and the blood stained my skin brown as it stayed visible as it dried. I spent every Christmas vacation in the first 12 years of my life, all 10 days, in the ICU with contagious risks of catching HIV, HPV, HCV, and HSV, internal bleeding, flu, and other contagious risks. The police murdered the employees of the propane company located on Route 13 in Harrington and Ivan's Florists located on Route 13 in Farmington. They combined the stolen identities of the murdered employees to form the Passwaters family

in Bridgeville, Delaware. They newly owned a large farm outside of town in Bridgeville. Around 10 years later, they built the large retirement community in Bridgeville in their stolen repeating identities. John Passwaters was a 4 year starter at quarterback at Woodbridge despite never winning a game. In my second grade year, and my ninth grade year, the police killed the whole faculty and occupied the school with their stolen identities as teachers. They held their place after their 9th grade shooting and remain now, I assume. They named themselves in their student identities as the entire honor roll and scholarship eligibility participants and have done their best to kill the entire student population, year after year. It is a misdemeanor to not attend school from the ages of 5 to 16 years old. I was reminded of this regularly and attended through the never ending threats and murders and murder attempts. In 3rd grade, in 1995, it was determined by the Delaware State Legislature that I am the only living student that started Kindergarten with me at Woodbridge. In 6th Grade, I won the President's Education Award and was visited by President Clinton and Vice President Gore. The President and the Vice President were shot at the assembly in the school auditorium in Greenwood. Several more of them were shot when we met for a week privately at Mayor Lawson's home in Millsboro. The Delaware Superior Court ruled that Amber Harris, because she is a Black student and

applied to win the award, rightly won the President's award. Amber's entry was only 1/7 complete. The 1/7 that she turned in was an example in the directions not to be used in the competition. The Superior Court awarded several other students in my class for their role in helping Amber with her assignment, but not me. I also contributed to one part of Amber's assignment. I remained, remain, in contact with President Clinton. In the school choice program, I visited several schools. When I was in Christiana and Archmere, the police attacked and killed students and residents who were collecting and building muscle cars. At least one neighbor still has possession of the murder evidence, his stolen muscle car. When I was at DuPont, I had to live at a private log cabin in a woods with no road to it to learn religion, French, and nursing, away from the police. When I did my residency and internships, I needed an armed guard from Linda, the Wight gang, and police attacks. The DuPonts have lived here for 500 years and cannot visit their homes or go out in public for sake of murder risks from the police and Wight gang for their red, blue, brown, and/or yellow skin. Daily violent attacks made by the police kept me from working in nursing at Milford Bayhealth hospital, and Merrill Lynch where I judged foreign currency. The foreign currency that I judged often had naked men and women who have never been involved in anal sex. I wonder why you are

not taking action considering everyone everywhere in your jurisdiction is a rape victim. The evidence is our unanimously false teeth and secondarily our undeveloped bodies and our poor health. The University of Delaware awarded me a full scholarship when I was 14 and 15. The Police and Wight gang violently acted against my scholarships twice, and twice got their way, and I had to leave school. They followed me to Milford High School on my first day of my sophomore year, and shot and attacked it. I have lost many friends and girlfriends this way. Because of their repetitive nature in doing this, I have a very poor reputation and am bad to know. By their will, I am diagnosed and treated for schizophrenia, for the past 15 years. It started with an arrest for Speeding by Milford Town cops. I was taken to the station in town and later transferred to Wyoming. The responding nurses in Milford refused to diagnose me with mental illness. In Wyoming, the nurses again refused, but an officer murdered one. In response, the nurses were coerced into diagnosing me with mental illness. This has happened several times over the past 15 years at Mental Health hearings, where the State Deputy Attorney Generals have drawn and fired killing judges and commissioners. The Court ordered medication, Invega, has four times caused me to develop life threatening heart diseases, and yet continually ordered to be prescribed despite the health risks by the Courts. 'Do no

harm' is the first and most important rule of medicine. I gained over 300 pounds related to rape. I have had heart diseases, diabetic, stroke, and other fatal risks, and brain damage related to amnesia. Between the ages 27 and 36, I have lost 300 pounds and maintained other vows to gain the title of Celtic. Three times I tried to return to school and was removed by the police and the Courts. I returned without notifying the Superior Court in 2019. I told the Superior Court when I had achieved the Honor Roll and was near graduation. The Superior Court attempted to remove me again, but Del Tech refused. I graduated in 2020 with a Legal Studies degree. I graduated in 2022 with a degree in General Sciences. I am studying Information Technology now and plan to graduate in 2024.

The birth certificate, the license, the social security number, the bank account, and car title, and the home deed are meant for one person, one human body- only. I have always been named Matthew Jones, born on March 3rd, 1986, at Milford Memorial Hospital, Social Security number 221-76-3652. I am a lifelong resident of Greenwood. I have lived at this location since 1991. The Cape Henlopen Conference maintains my school records. Refer to the back of the \$1 bill. The shining pyramid is a remake of a very famous and often remade painting. The painting and the pyramid's tip show the first time that the satellites in outer space began recording all

activities on the seven continents of every person, 24 hours per day. This technology is thousands of years old now. It was made during the threats of Ja and his slaves the Wights worshiping the verbal religion of No Survivors. It was made before the modern Christian calendar. Everything we do is seen. Plainly, you cannot become someone by murdering them and manipulating your face, hair, and voice, to look like them from the neck up. Linda has been in at least five different body types in my lifetime. I keep photos of all of my life around the house, on facebook, on Google, and at other sources. Plainly the police officers and the Delaware Courts, including the Family Court are not citizens and are identity thieves. Identity thieves are murderers, very obviously. We spent the first 7 years in school, K-6, talking about identity thieves, people who dedicate themselves to slavery in racism to all on Earth, serving Black males sexually. Actors who murder their role, pedophiles, rapists and torturers of all living things. We talk about how the Wights move to America after murdering the rest of Africa in Black service. We talk about their mad runs on foot all the way to India after noticing the recording devices in Egypt go all the way up to the stars. We talk about the Devil. We talk about Dill Farms. We talk about Thanos, and France, Greece and Hippocrates and Deux ex machina, Athens and Sparta, Rome and J.C., Romulus and Remus, Lushii and Jon,

video games and Green Africa, slavery, servitude, feudalism, conditioning, torture, masses, the Silk Road, the Silt Road, the Red Plague, the Blue Plague, Hay Fever, Agent Orange, The Green Plague, The Black Plague, The Black Death, AIDS, Ebola, Gaia, La, Latin, Islam, Germany, Byzantium, Normands, Celtics, England, Bourgeoise, El, Les, II, and Phi. School is mandatory attendance or else. Missing a certain number of school days will lead to a misdemeanor crime charge and a jail sentence. Every missed school day after the charge is written will cause another misdemeanor charge. It's a shame that I'm the only Delawarean who attended school. When I look around businesses, particularly Courts, law offices, prisons, and police stations and I see that no one in the whole staff has changed, and no one has aged, since I was in high school in 2004- I wonder what comic book or TV you are characters in: Wallace and Gromit, Chutney, Barney Miller, hmm..I should not have to live with my murderer, who has many many times caused my body to die. I should not have to live around my murderers gang as it patrols law enforcement and controls crime in punishment. I deserve a life. I have living rights. Everyone born here does. What identity thieves do to newborn babies is rather unbelievably hideous. There's never been a baby born or animal that deserved what you've done to us. There are two people in English written

history who have suffered and died and resurrected and been returned to their murderers attacks like I have been. The other victim was attacked by the same identities of police combined with murderous gang members in anal sex service to Black males. He was a nephew to Emperor Han in China. For the first 40+ years of his life, the Wight gang and its police attacked his medical supply farm, murdering him and his family, and using his medicine to bring him back to life and kill him hundreds, and then thousands more times. I am the only other victim of this madness. Mine are ongoing. The Devil attacked a single victim once for 12 years, in the Devil's identity. Widower the Niger's identity attacked a victim for 12 years as well. All murderers, in every race, live the same 8 months. Linda has been attacking me with the power of law enforcement since the day that I was born. The longest that any single murderer attacked any single person is 8 months before dying. Multiple Linda's have tied this record, against me and certain men and women living in Rehoboth Beach 1970-now. The eye of Isces is always open and on all seven continents. The back of the U.S.A. one dollar bill denotes this. Identity theft is a crime. Identity theft is a felony listed in the U.S. Title Code relating to all 50 U.S.A. States. No one in written English history, dating back prior to the formation of Rome, has done a worse job in their profession than you. When you go to Wawa and

order a sub, you expect a sub. When you pay for your gas you expect to get gas for your vehicle. Your robe implies that you are a Judge of U.S. written laws, not common laws, bench decisions, religious beliefs, or anything other than the laws written by the Legislative Branch of government. On the door of the buildings that you are located in, it reads Court. The job titles that you have are in the U.S. Law, whether it specifically says Attorney General, Deputy Attorney General, Attorney, Public Defender, Commissioner, or Judge. On many police vehicles, 'Law Enforcement' and 'Protect and Serve Citizens,' is written. The police are a power of the Judicial Branch of government. You are their bosses. The Judicial Branch is the 3rd branch, the 2nd is Legislative, the 1st is Executive.

As much as I expect to get what I request at Wawa, I expect to get it from the police, the attorneys, the medical examiners, the State appointed doctors, The State's Attorneys, and the Courts.

## **REASONS FOR GRANTING THE WRIT**

1. To address the questions presented by the Petitioner at the beginning of this petition.
2. To explain the popular defense “sovereign immunity” used by the Court system in support of police officers and others when they are Defendants, over 200 years after the Revolutionary War was fought - ending in the creation of the democracy of the United States of America and the end of the government of the British 13 Colonies and the reign of King George in the United States of America.
3. To explain the allowances of the Court for the unanimous use of Rock-Lobster DNA by Black people and Black mixed people in a guise that they are White, White according to the Courts, meant in murderous racism, scalping, identity theft, obscenity, rape, and impersonation of all Whites and White mixes.
4. To explain the allowances of the Court toward Black people and Black mixes to use DNA to impersonate the Chinese and Latins, and all races with legal identification provided that they are actually in these races- to murder the Chinese, Latins, and others and slander and torture them, rape, and so on, as they treat Whites and White mixes.

5. To explain the absolute racism of the Courts directed at me and my female gender. Allowing the police to remain in my presence, at all times, after killing me 1000 times in every stage of life from my mother's womb to old age (37), in every walk of life from homeless to millionaire, in every degree of merit from mentally ill to a judge of foreign currency, to a record setting student, to a prescription nurse, to an aid to the State Senator, to U.S. Constituent, and a citizen and all of the above.
6. To explain the Court's support of the police force, ignoring all of the felonies committed by each officer related to identity theft, murder, pedophilia, rape, torture, poisoning, explosives, battery, assault, kidnapping, and confinement.
7. To explain the Court's support of the Identity of Linda C. Jones, whose face and personality are remembered in Dante's Inferno, in the Wight Gang, in the 1000 fatal rapes of Emperor Han's nephew, in the rape of Dill Farm, in the 1000 murders of orphan Black in France, in the persona of Outlaw: Rape Victim?! in Africa, in paintings related to the pyramid surveillance depicted on the back of the dollar bills, in the depictions of the Outlaw and Police Officer Angie, and in Medusa.
8. To explain the Court's stance on gods, kingdoms, and consent.
