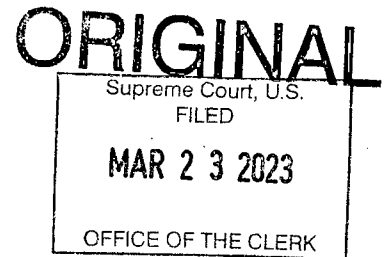

### STATEMENT OF THE CASE

On October 3, 2022, Petitioner filed a criminal Action Motion. On October 4, 2022, Petitioner prose Motion was denied without review. On November 21, 2022, U.S. Court of Appeals summarily Affirmed Judgment. On December 7, 2022, Petitioner Motion for an extension of time to file a petition for rehearing is granted. On December 27, 2022, Petition for rehearing filed. On January 18, 2023, Petition for rehearing by the panel is denied.

### REASONS FOR GRANTING THE PETITION

The U.S. Court of Appeals has entered a decision in conflict with the U.S. District Court by summarily affirmed the district court denial of Petitioner's prose Motion arising a Fifth Amendment due process violation of (Miranda Rights) without review, analysis and conclusion of the constitutional claim. Both lower courts are avoiding and denying to address the merit of a guaranteed protective constitutional Right to due process of law and denial of review will affect petitioner's substantive due process rights to review. This rise a important federal question that require the Supreme court discretionary Jurisdiction of review of the conflict of Both lower courts and Petitioner should be grant Certiorari.

### CONCLUSION

The petition for a writ of certiorari should be granted.
