AFFIDAVIT- JURAT IN SUPPORT TO PROCEED IN FORMA PAUPERIS

Mapes of which this case also involves in accessibility of services that directly involve the of early stages of development , are the petitioners in the above-entitled case. In support of Our motion to proceed in forma pauperis, We state that because of Our poverty We are unable to pay the costs of this case or to give security therefor; and We believe We are entitled to redress.

Income Source : SSI and SSDI falls 200% below federal poverty level [less than 1,000 month](See 42 U.S.C.. 407(a))

Public-assistance : SNAP and TANF including the above SSI & SSDI falls 200% below federal poverty level

Total Income: a little over 1,400\$ a month combing both SSI, SSDI and Public Assistance.

After paying home-mortgage payment with included property insurance , electricity, heating fuel(gas), water, sewer, telephone , food, laundry , clothing , etc (Basic necessities of household and dependents We have nothing left but we have all are necessities. We do not expect any major changes to our income in the next 12 months either . We can not afford counsel either .

We can not pay nor make all the copies needed in light of Our low income and this is assignment of said SSDI and SSI income to this legal process and at law is causing an impact to and affecting what we need to ensure all our basic necessities
